

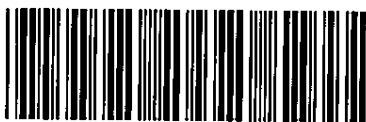

**NOTES TO THE ACCOUNTS**

- The accounts have been prepared under the historical cost convention in accordance with applicable UK accounting standards and on a basis consistent with the previous year
- The Company has not traded during the year, has incurred no liabilities and, consequently, has made neither profit nor loss. None of the directors received any emoluments in respect of their services to the Company
- The Company owns 55% of the issued ordinary share capital of Thomson Publishing Group Limited, a company incorporated in England and Wales. Group accounts have not been prepared as the Company is a wholly owned subsidiary of another company incorporated in England and Wales. The directors are of the opinion that the value of the Company's investment in its subsidiary is not less than the amount at which it is shown in the balance sheet
- The Company is a close company within the meaning of Section 414 of the Income and Corporation Taxes Act 1988. The Company's immediate parent company is Thomson Holdings Limited. Within the meaning of the Companies Act 1985, Thomson Investments Limited ("TIL") is regarded by the Directors of the Company as being the Company's ultimate parent company and controlling party. Within the meaning of the said Act, The Thomson Corporation ("Thomson") is the parent undertaking of the only group of undertakings for which group accounts are drawn up and of which the Company is a member for the period ended 31 December 2007. On the 17 April 2008, Thomson acquired Reuters Group PLC ("Reuters") by implementing a dual listed company structure. Under this structure Thomson Reuters will have two parent companies, both of which will be publicly listed, Thomson Reuters Corporation a Canadian company and Thomson Reuters PLC being the new English company. From this date forward, the Company will be included in the group accounts of Thomson Reuters PLC and Thomson Reuters Corporation ("Thomson Reuters"). TIL, Thomson and Thomson Reuters are incorporated under the laws of the Province of Ontario, Canada. Thomson Reuters PLC is incorporated under the laws of England and Wales.
