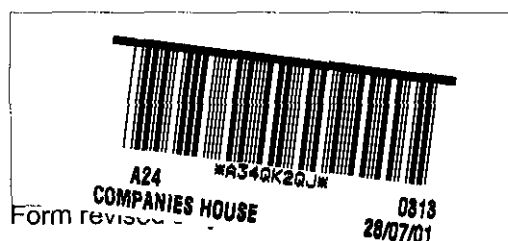

## NOTES
