BACKGROUND

- 1. Pursuant to a share sale agreement between the Computershare Document Services Limited ("CDS") and Computershare Investments (UK) Limited ("CIUK") dated 30 June 2004 (the "Share Sale Agreement"), CDS sold to CIUK its holding of 1,050,000 ordinary shares of £1 each in Computershare Investor Services PLC (the "Shares") in return for a deferred consideration of £24,500,000 payable in full on or before 30 June 2007 on which interest will accrue from the Completion Date to the Repayment Date at an annual rate equal to 0.2% plus the base rate from time to time of The Royal Bank of Scotland plc (the "Deferred Consideration").
- CDS declared a dividend in specie in the sum of £245,000 on 20 June 2004 on each
 ordinary share in the capital of CDS which was satisfied by the assignment to the sole
 member of the CDS, CDS International Limited (the "CDSI") of the benefit of the Share
 Sale Agreement and the debt owing by CIUK to CDS under the Share Sale
 Agreement.
- CDSI declared a dividend in specie totalling the AUD equivalent of £24,500,000 which
 was satisfied by the assignment to the sole member of CDSI, ACN 080 903 Pty
 Limited ("ACN 080") of the benefit of the Share Sale Agreement and the debt owing by
 CIUK to CDS under the Share Sale Agreement.
- 4. ACN 080 declared a dividend in specie totalling the AUD equivalent of £24,500,000 which was satisfied by the assignment to the sole member of ACN 080, Computershare Limited (ACN 005485825) (the "Assignor") of the benefit of the Share Sale Agreement and the debt owing by ClUK to CDS under the Share Sale Agreement.

ASSIGNMENT
