It was reported that following the merger in the UK of Coopers & Lybrand and Price Waterhouse, which was completed on 1 July 1998, Coopers & Lybrand had, in accordance with the requirements of the Partnership Acts and the Companies Acts, given notice of their intention to resign as London Electricity plc's auditors.
