# THE FRIENDS OF CASTLE SYCHROV (UK) LIMITED REPORT OF THE DIRECTORS FOR THE YEAR ENDED 31 DECEMBER 2002

The Trustees who are Directors for company law purposes present their Report to the members with the Accounts and Notes thereto.

### **GOVERNING INSTRUMENT**

The company is a registered Charity and is governed by its Memorandum and Articles of Association. The object of the Charity is to preserve and restore Castle Sychrov in the Czech Republic its historic contents and the parkland surrounding and belonging to it for public appreciation. There have been no changes in the Charity's object or policies during the year.

## **REVIEW OF ACTIVITIES**

During the year covered by these accounts the Charity made grants totalling £ 7,600 to Sychrov and also made a donation of £ 500 to the Czech Flood Disaster Fund.

Administration expenses during the year amounted to £877.

The year's efforts were focused on continued support to the Castle administration in its restoration and conservation of the Castle and Park. The UK Friends funded further repair of the park/kitchen garden wall; this is now very nearly complete. The Friends also supported repairs to the outer perimeter wall and the restoration of a marble fountain basin. The Castle administration has funded renovation of several rooms to be museum rooms and one room on the *piano nobile* decorated à *la Chinoiserie*.

The management hosted many events which bring in vital revenue.

All construction matters continued to be under the expert supervision of Ing.Arch. Karel Ksandr. Ing.Arch Jan Hendrych, Head of the Department of Historic Cultural Landscapes at the *Silva Taronca Research Institute* for Landscape and Ornamental Gardening at Prùhonice continued his supervision of work in the Park for The Friends.

In May, for The Friends of all national branches, there was a weekend of visits to Josselin and other significant Rohan properties in Brittany. In the spring Ing.Arch Jan Hendrych gave a lecture on 'Bohemian Paradise - The Historic Cultural Landscape of the Czech Republic' at the Czech embassy in London, by kind permission of H.E. The Ambassador.

The Charity's Income in 2002, derived from donations, subscriptions, interest, and profit from the Brittany visits and London lecture. These totalled £ 7,111 (US subscriptions totalled 42.84 US\$.).

There was a subtraction of £ 1,866 to the accumulated surplus leaving a surplus carried forward at 31st December 2002 of £ 3,630.

The Board of Directors met formally once, specific directors informally several times and with our Special Advisor, who made several trips to Bohemia, reviewed progress and helped us consider project suggestions from the Castle management and also further fund-raising initiatives. It is felt that The Friends of Castle Sychrov (UK) should continue to concentrate the majority of its grants towards the vital but often less apparently 'exciting' projects that need to be done, mostly in the Park. Work on the Park Wall, adjoining the Kitchen Garden began in 1997 and by December 2003 is expected to be complete.
