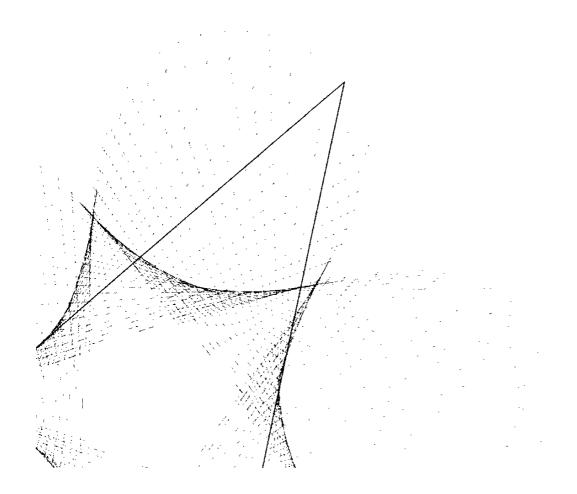

1 Introduction and Statutory Information
