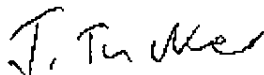

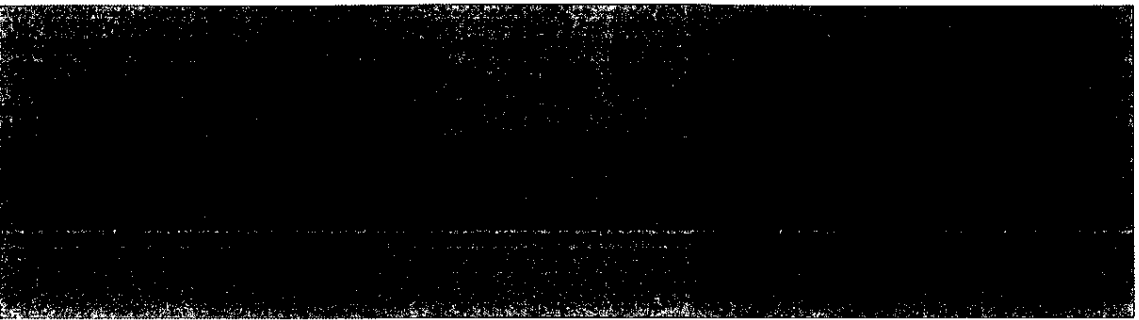

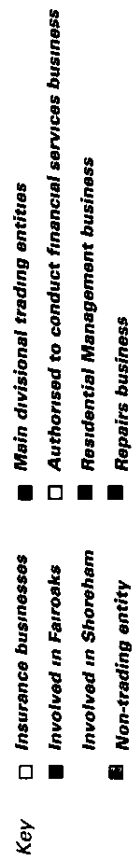

Executive summary



- This progress report covers the six month period from appointment to 13 October 2008
- The Administrators' Statement of Proposals were approved on 19 July 2008 and have not been modified (see page 6, Statement of Proposals)
- Since the last report the Administrators have continued to progress the administrations to achieve the statutory purpose and in line with the proposals. This has included the realisation of assets which now largely consist of trade debtors. In addition Administrators' staff have been engaged in managing the separation of the businesses as set out in the proposals. The Administrators intend to pay a dividend to preferential creditors in a number of entities. Potential returns are being generated for unsecured creditors by way of the Prescribed Part as a result of floating charge realisations. These are detailed on page 10
- Based on the expected level of realisations and the amounts owed to the secured creditors, there is no prospect of funds being available for unsecured creditors other than from the Prescribed Part

- There were approximately 125 companies in the Group and the principal trading entities are shown in the above chart

Statement of Proposals

Proposals to creditors
were approved on 19 July
2008.

- In accordance with Paragraph 49 of Schedule B1 to the Insolvency Act 1986 the Administrators are required to issue their proposals to creditors for achieving the purpose of the administrations within eight weeks of their appointment on 14 April 2008
- Due to the complexity of the Group's affairs an extension to the deadline was granted by the Court and the Administrators' Statement of Proposals was circulated to all known creditors on 7 July 2008
- As the company had insufficient property to enable a distribution to unsecured creditors, other than that by virtue of the Prescribed Part, the Administrators are not required to convene a creditors meeting unless, as set out in the Statement of Proposals, one is requested by creditors. No such meeting was requested. As a result, in accordance with Rule 2.33(5) of the Insolvency Rules 1986, the Statement of Proposals as circulated was deemed approved on 19 July 2008

Progress of the administrations to date

The administrations

continue to be progressed to achieve their statutory purpose and in accordance with the proposals issued on 7 July 2008

Summary of progress by division since appointment

The Insurance, Residential Management and Repairs Divisions

- As reported previously these divisions, which were not subject to administration appointments, were successfully sold to Caley, a vehicle owned by the Banks. These transactions have helped to protect the jobs of around 1,800 employees. Since the sale the Administrators have undertaken an exercise to separate the operations of the sold businesses from the remainder of the Group. All costs in relation to this exercise, including the time costs of the Administrators, are being funded by the relevant counterparty.

Building Consultancy Division

- The management of the individual businesses in this division consisted of their former owners and it was possible, with the assistance of senior management, to achieve a rapid sale of these businesses in order to maximise the realisations for the estate. Eight business sales were completed in this division which have realised in excess of £3 million (including recoveries from debtors). Details of the individual transactions were provided in the Statement of Proposals.

Professional Services and Commercial Management Divisions

- In view of the interest from the management of certain businesses in this division, the Administrators were able to complete seven transactions. These transactions realised £3 million (including recoveries from debtors). Details of the individual transactions were provided in the Statement of Proposals.

EG Plc and head office function

- The disposals to Caley and certain other business disposals required that the Administrators maintained a head office function for a period under a transitional services agreement. The central services maintained include IT facilities, Human resources, Payroll, Accounting and other services. The costs of these transitional services, which are shown in the Receipts and Payments Accounts contained in Appendix 2, are being borne by the relevant counterparty. These arrangements are now being brought to a close.

EMS

- As reported previously, a number of contracts within EMS were transferred to the Repairs division. The result of this was that customer continuity was maintained to improve debtor recoveries and 300 employees within EMS were transferred.

Assets realised to date

The assets of the Adminicos consisted primarily of leasehold and freehold property, trade debtors, client account debtors, tangible assets and investments.

Leasehold and freehold property

- The sale of business agreements included the interest in 78 of the group's 154 premises
- 65 leases were not included in sale of business agreements, and surrenders have been agreed on 11 of these properties and are awaiting acceptance of surrender from the remaining 54 landlords. These properties remain vacant. Landlords are not under any obligation to accept surrender of the leases and some ongoing management of the properties may be required until the lease liabilities are discharged
- Agents were unable to secure premiums for any of the leases, and we are no longer marketing these interests
- A licence to occupy the freehold property at Plympton Street, London was granted to Caley who also purchased an option to purchase the freehold interest. This option was exercised on 22 September 2008
- The Administrators appointed a specialist agency, Capa, to seek to recover any overpaid or appealable rates on a contingent fee basis. Capa have recovered £17,221 to date

Trade debtors

- On appointment, gross debtors totalled £19.2 million of which £1.2 million were intercompany balances. To date £7.0 million has been recovered from trade debtors. Our specialist receivables realisation team continues to pursue the outstanding amounts detailed above

- A significant driver of future collections will be the recoveries from client account debts, which account for £2.2 million of the total sales ledger across four entities and eight ledgers. Identifying client account debt and the managing agents has been a time consuming process, however £377,000 has been recovered to date

- Following investigation intercompany balances of approximately £800,000 have been identified that may be recoverable. These balances arise from pre administration transactions between entities currently in the administration process and former group entities that have been sold during the administration

Tangible assets

- An agent has been appointed by the Administrators to progress sales of all plant and machinery, fixtures and fittings, and IT equipment. In addition to amounts shown under furniture and equipment in the receipts and payments accounts realisations from these sources held by agents total £28,000 (excluding VAT)

Investments

Sale of the Insurance, Residential Management and Repairs Divisions

- As noted in the 'Progress of administrations to date', the Insurance, Residential Management and Repairs Divisions have been successfully sold to a vehicle owned by Erinnaceous' banks

Sale of interest in Stockley Park joint venture

- ISGO Limited is the holding company for EMS. It also held a 49% stake in a joint venture, Stockley Park Management Limited, this is a property management company managing Stockley Park, Heathrow. The Administrators have now achieved a sale of this shareholding for £285,000

Realisation from the MC Property Growth Fund

- The Administrators of ISGO Limited have also realised £212,000 representing a 90% distribution following the winding up of the fund

HLR debtors

- A sum of approximately £700,000 has been realised in respect of deferred consideration arising from the pre-administration sale and leaseback of the Group's head office in Croydon

Building consultancy – deferred consideration

- A sum of £200,000 was recovered as part of an agency collection agreement to secure consideration against future debtor recoveries in Building consultancy

Liabilities

The Administrators

continue to manage a large number of client money accounts in order to seek to identify the beneficial owners

The Administrators

forecast that there will be a return to Preferential Creditors in certain Administrators.

Client money

- Client money held within the Professional and Commercial division at the date of the administration appointments totalled approximately £35 million. Subsequently, this was mitigated as a significant number of existing contracts were transferred to a third party as part of the pre-administration sale of the Professional and Commercial businesses
- However, 143 clients with existing contracts did not transfer and therefore remained to be dealt with in the administration. A further 215 client accounts existed where the clients' contracts had terminated prior to the administration but where their client accounts had not been reconciled and closed
- The Administrators identified the remaining client monies totalling approximately £4.4 million on behalf of those clients and transferred funds to new client accounts controlled by the Administrators
- Since appointment, the Administrators have been seeking to ensure that the Administrators have continued to discharge their duties in relation to the client accounts, and more specifically
 - To verify the status of these accounts, and
 - To identify any third party beneficiaries of the client money bank accounts and the new property managers
- In association with their legal advisors, the Administrators have formulated procedures to resolve the issue of the return of relevant funds to the beneficiaries or their new property manager. To date 92 of the 143 existing clients have been contacted, 19 of which have confirmed acceptance of the proposal. These 19 clients have so far been paid in full at a total approximate value of £437,000

Secured creditors

- Amounts due to secured creditors and distributions made to them to date are set out in previous reports and in this report's receipts and payments accounts

Preferential creditors

- Preferential creditor claims are forecast to total £613,000 across the Administrators. The latest forecast has been calculated incorporating details provided by staff as part of the redundancy process managed by the Administrators. Please refer to the table below for the division between companies

- The Administrators do not anticipate any return to preferential creditors of EG Plc. The Administrators currently forecast there will be sufficient funds available to enable at least partial distributions to preferential creditors of the remaining entities detailed in the Prescribed Part table on page 10

Liabilities (cont.)

The Administrators anticipate that any return to unsecured creditors will be from the Prescribed Part.

Prescribed Part

- The Prescribed Part is a fund set aside for the unsecured creditors from floating charge funds of approximately 20% of net assets, up to a maximum of £600,000 in each estate
- The Prescribed Part across the Group is forecast to total £1 075 million. Please refer to the table below for the division between companies

- These estimates of the Prescribed Part are based on the current view of the estimated outcome in each administration. The Administrators continue to review the outcome for each entity and as realisations increase the actual amount of the Prescribed Part payable, subject to the maximum of £600,000, may increase

Unsecured creditors

- As advised in the Statement of Administrators' proposals under Paragraph 49, the Administrators do not anticipate there will be any return to unsecured creditors, other than via the Prescribed Part
- Details of potential unsecured creditor's claims were provided in the Statement of Administrators' proposals under Paragraph 49. The details contained in this statement were provided by the Directors the Admincos and additional claims received after 7 July 2008 have been added to the records of the Administrators

Costs of administrations

Costs of administrations

- The costs of administrations paid to date are set out in the attached Receipts and Payments Accounts (see Appendix 2)
- The Administrators' time costs for the period up to 19 September 2008 are attached to this report (see Appendix 3) This same schedule has been provided to the Banks and the remuneration has been approved by them up to this date
- In accordance with Rule 2.106 (5a) of the Insolvency Rules 1986, where there will be a dividend to preferential creditors in a particular entity, a simple majority of these creditors voting will also be required to approve the basis of the Administrators' remuneration drawn from that estate This approval will be sought by the Administrators under separate cover shortly

Future realisations

The Administrators continue to supervise the realisation of remaining assets.

Remaining assets

Leasehold and freehold property

- The remaining freehold and long leasehold interests which hold potential value are summarised below. The premises at Tewkesbury is included with the sale of business agreements and is currently occupied under a licence agreement.

- Agents have been instructed by the Administrators for each of the above properties and appropriate disposal strategies have been adopted
- Land registry searches have not identified any additional freehold properties
- Specialist agency, Capa, continue to seek to recover any overpaid or appealable rates on a contingent fee basis

Trade and client account debtors

- The Administrators continue to collect out the trade debtors across the Adminco's as described in page 8
- Remaining client account debtors total approximately £2 million. However, due to the insolvency of the Group the administrators do not forecast any significant recoveries from this source

- With regards to remaining client debtor balances, key employees have been incentivised and retained to continue the reconciliation and collection process set up by our Specialist Receivables Realisation team. Members of the Group's credit control team will continue to chase clients directly for the debt where there is no prospect of funds being available in the client account and where written consent is not obtained to offset debt owed from monies held by Ennaceous debt.

Tangible assets

- The majority of the Group's tangible assets have now been disposed of and the level of realisations is detailed in the receipts and payments account. A balance of £28,000 plus VAT is held by the instructed agents but it is anticipated that this will be utilised to meet costs.

Investments

- The majority of the Group's investments have now been disposed of and no significant items remain.

Investigations

- Investigations are being performed by the Administrators in accordance with their statutory duties. The Administrators have complied with requirements under the Company Directors Disqualification Act 1986.
