

- (3) The Applicant be removed as trustee in bankruptcy and Martin Christopher Hepworth do replace the Applicant as trustee in bankruptcy in the cases set out in Part B of Schedule 1 hereto;
- (4) The Applicant be removed as Supervisor of the Individual Voluntary Arrangement (IVA) and Peter Adrian Finn do replace the Applicant as Supervisor of the IVA in the cases set out in Part C of Schedule 1 hereto;
- (5) The Applicant be removed as Joint Administrator and Martin Christopher Hepworth do replace the Applicant as Joint Administrator in the case set out in Part D of Schedule 1 hereto;

- (11) The Applicant be removed as Provisional Liquidator and Peter Adrian Finn do replace the Applicant as Provisional Liquidator in the cases set out in Part K of Schedule 1 hereto;
- (12) The Applicant be removed as Joint Supervisor of the Company Voluntary Arrangement (CVA) and Martin Christopher Hepworth do replace the Liquidator as Joint Supervisor of the CVA in the case set out in Part L of Schedule 1 hereto;
- (13) The Applicant be removed as Supervisor of the Company Voluntary Arrangement (CVA) and Peter Adrian Finn do replace the Applicant as Supervisor of the CVA in the cases set out in Part M of Schedule 1 hereto;

(14) The Applicant be removed as Joint Trustee in Bankruptcy and Peter Adrian Finn remain as sole Trustee in the case set out in Part N of Schedule 1 hereto;

(15) The Applicant be entitled to publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette.

(16) Without incurring any additional expense to any of the said estates, the Respondents shall when the next report is due to creditors of each estate, notify each creditor of the making of this order, such notice to contain the following matters:

- 15.1 An explanation of the effect of the Order
- 15.2 Express reference to the permission to apply below
- 15.3 The provision of all such information as might reasonably be required as part of that report with regard to the conduct of the bankruptcy, voluntary arrangement, administration, liquidation, provisional liquidation (as the case may be)
- 15.4 In the case of compulsory liquidations and bankruptcies under the Insolvency Act 1986 where liquidation or creditors' committees have been appointed, an explanation that, to the extent that any such information which would otherwise be required to be provided under insolvency rule 4.108(3) or rule 6.126(2) has not

already been provided as part of the routine report, it is open to that committee to require the Applicant appointed do provide an account of the administration of the estate including :-

15.4.1 Summary of receipts and payments

15.4.2 A statement that he has reconciled his accounts

15.5 In the case of compulsory liquidations and bankruptcies under the Insolvency Act 1986 where no liquidation or creditors' committee have been appointed, an explanation that, to the extent that such information has not already been provided as part of the routine report, it is open to any creditor to apply to court for an order that the Applicant appointed do provide such information as might otherwise be required by Rule 4.108(3) or Rule 6.126(2) (as the case may be) that is to say, an account of the administration of the estate including:-

15.5.1 Summary of the receipts and payments

15.5.2 A statement that he has reconciled his accounts

15.6 Notification that if any Applicant appointed has been required to provide the information referred to above, whether by the liquidation/creditors' committee or by Court Order on the application of any individual creditors, the appointed Applicant's costs of so complying will, unless there are good reasons to the contrary, be paid as an expense of the bankruptcy, administration, arrangement or winding up as the case may be.

- 15.7 In the case of liquidation under the Insolvency Act 1986, notification be given to each creditor of his right under rule 11(1) (compulsory winding up) and rule 11(2) (voluntary winding up) of the insolvency regulations 1994 to require the appointed Applicant to supply a Statement of Receipts and Payments free of charge.
- 15.8 In the case of bankruptcies under the Insolvency Act 1986, notification be given to each creditor of his right under rule 25 of the Insolvency Regulations 1994 to require the appointed Applicant to supply a Statement of Receipts and Payments free of charge.
- 15.9 Permission be granted to each creditor of each estate to apply to vary or discharge this Order within 21 days of posting of the notices or letters directed to be sent under Paragraph 15 above.
- 15.10 The costs of the application herein (including the VAT) be paid as an expense of each of the insolvency proceedings identified in Schedule 1, the cost to be aggregated and apportioned equally amongst each of the said proceedings provided that:

- (i) if the costs which fall to be borne by any of the proceedings exceed 10% of the readily realisable assets within that proceeding, then the proceeding shall only bear part of those apportioned costs, that part being equal to 10% of that proceedings' readily realisable assets; and
- (ii) the excess shall then be apportioned and borne equally by the remaining proceedings

15.11 Service of the said Notice of Application be dispensed with.
