1 Accounting policies

Castle Environmental Limited (the "Company") is a private company incorporated, domiciled and registered in England in the UK. The registered number is 03092243 and the registered address is Treatment Centre, Crompton Road, Ilkeston, Derbyshire, DE7 4BG.

These financial statements were prepared in accordance with Financial Reporting Standard 102 *The Financial Reporting Standard* applicable in the UK and Republic of Ireland ("*FRS 102*") as issued in August 2014. The presentation currency of these financial statements is sterling. The financial statements are prepared on the historical cost basis.

In the transition to FRS 102 from old UK GAAP, the Company has made no measurement and recognition adjustments. FRS 102 grants certain first-time adoption exemptions from the full requirements of FRS 102, and the exemption for dormant companies has been taken in these financial statements such that the accounting policies for reported assets, liabilities and equity at the date of transition have been retained until there is any change in those balances or the Company undertakes any new transactions.

The Company's ultimate parent undertaking, Hillbridge Investments Limited includes the Company in its consolidated financial statements. The consolidated financial statements of Hillbridge Investments Limited are prepared in accordance with International Financial Reporting Standards as adopted by the EU and are available to the public and may be obtained from Treatment Centre, Crompton Road, Ilkeston, Derbyshire, DE7 4BG.

2 Ultimate parent company and parent company of larger group

The Company is a subsidiary undertaking of Hillbridge Investments Limited. The ultimate controlling party and the largest and smallest group in which the results of the Company are consolidated is that headed by Hillbridge Investments Limited.
