At an Extraordinary General Meeting of the Company duly convened and held on 1 Spt. 1995 the following resolutions were carried as Special Resolutions as appropriate:

#### SPECIAL RESOLUTIONS

- That, the name of the Company be changed to Goldwell Marketing Communications Limited.
- That, the objects of the Company as set out in its Memorandum of Association be and they are hereby altered by the insertion of the following new sub-clauses and a consequent relettering of subsequent clauses:-
  - "A To carry on the business of marketing and market research and general economic or commercial research and to act as consultants and advisers to persons, firms or companies requiring the research services provided by the Company and printers, graphic designers or publishers of all kinds (including without limitation trade and other periodicals, newspapers, magazines, books and journals), advertising and publicity agents in all their branches, journalists, press photographers and press cutting agents in all their respective branches, market research and mail order specialists, general, lithographic, photostatic and photographic printers, blockmakers, paper and ink manufacturers and dealers and stationers.
  - B To undertake typing, copying, duplicating, the use and creation of electronic files, optical files and syquestic discs, addressing, engraving, lithographing and photographing, stereotyping, printing, bookbinding, adding and calculating, translating and advertising work of all kinds; and to supply secretaries, accountants, registrars, reports, shorthand writers, typists, copyists and secretarial, clerical and other assistance of all kinds.
  - C To carry on the business of commercial artists, industrial artists, advertising artists, artistic consultants, photographers, designers and illustrators, publicity agents and contractors, sales consultants and specialists, exhibition, display and window dressing specialists; and to undertake and transact agency work of all kinds for advertising agents and contractors."

#### ORDINARY RESOLUTIONS

That the authorised share capital of the Company be and it is hereby increased from £100 to £1,000 by the creation of 900 additional shares of £1 each.
