

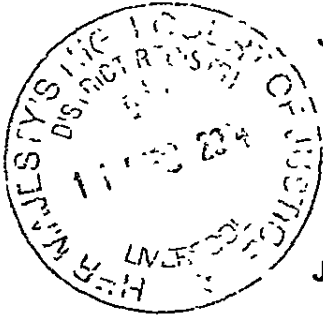

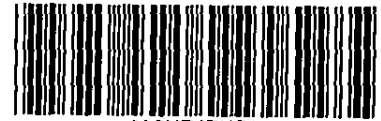

DRAFT ORDER

Upon the application of Robert M Rutherford, Paul J Fleming, John P Fisher and Ian C Brown for a block transfer of cases dated 27 November 2014 and upon reading the witness statement of Richard Clive Thomas dated 27 November 2014 and without a hearing pursuant to Rule 7.10D(2) of The Insolvency Rules 1986 it is hereby ordered:-

1. 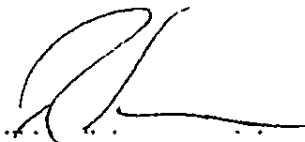

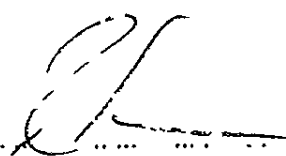

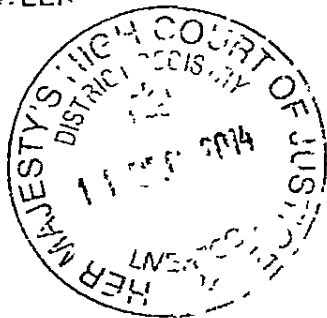
