

- (e) deal with its book and other debts, except by collecting them in the ordinary course of its business. In particular, the Company will not realise its book and other debts by means of invoice discounting or factoring arrangements,
- (f) grant, or accept a surrender of, any lease or licence of any of its Land or consent to a tenant assigning or subletting,
- (g) dispose of, part with or share possession or occupation of any of its Land
