**Directors' Report** 

The directors present the audited financial statements of ALD Automotive Group Limited ("the Company") for the year ended 31 December 2018. The Company is a limited liability company domiciled and incorporated in the United Kingdom.

#### Results and dividends for the year

The overall profit for the year after taxation amounted to £40,853k (2017: £36,221k). At the balance sheet date, total assets of the Company stood at £22,945k (2017: £22,945k) with net assets of the same amount as the Company had no liabilities.

During the year, a dividend of £40,853,000 (10.2p per share) was paid (2017: £36,221,000, 9.1p per share). Subsequent to the balance sheet date no dividend is proposed in relation to the year ended 31 December 2018.

#### **Directors**

The directors of the Company in office during the year and to date of approval of these financial statements are as listed on page 1.

No director held any beneficial interest in the issued share capital of the Company at 31 December 2018. In accordance with the terms of the Articles of Association, the directors are not subject to retirement by rotation.

All directors have the benefit of a contract of indemnity. This was in force during the whole of the year.

#### Re-registration as a private company

The Company, which was formerly registered as a public company, was re-registered under the Companies Act 2006 as a private company with effect from 4 May 2018. The name of the Company was changed accordingly from ALD Automotive Group PLC to ALD Automotive Group Limited.

#### Disclosure of information to the auditors

So far as each person who was a director at the date of approving this report is aware, there is no relevant audit information, being information needed by the auditor in connection with preparing its report, of which the auditor is unaware. **Strategic Report** 

#### Business review, principal activities and future outlook

The Company is an intermediate holding company with all income attributable to dividends from its subsidiary undertakings. During the year, the Company received a dividend of £40,853k (2017: £38,475k) from its subsidiary undertaking ALD Automotive Limited.

The Company's principal activity remains that of a holding company and the directors expect this to continue for the foreseeable future.

#### Principal risks and uncertainties

Principal risks are those which the directors believe could materially affect the performance of the Company. Due to the nature of its business the Company is not directly exposed to market risk or liquidity risk.

The principal risk facing the Company relates to the valuation of its investments. Impairment is currently not considered likely as the net asset value of the subsidiary undertaking is significantly higher than the respective book value in the financial statements.

#### 1. ACCOUNTING POLICIES

#### Basis of preparation

The financial statements are prepared under the historical cost convention, as modified by the revaluation of financial assets and liabilities at fair value through income as set out in the relevant accounting policies and are prepared in accordance with International Financial Reporting Standards (IFRS) as adopted by the European Union.

The presentation currency is sterling (GBP). Amounts disclosed are rounded to the nearest £1,000.

The Company is exempt by virtue of IAS 27 "Consolidated and Separate Financial Statements" from the requirement to prepare group financial statements. These financial statements present information about the Company as an individual undertaking and not about its Group.

#### **Investments**

Investments in subsidiary undertakings are held initially at cost, being the fair value of the consideration given to acquire the holding. Investments are subsequently recorded at cost plus any further capital contributions and less any provision for impairment in value. The carrying value is reviewed for impairment annually.

#### **Dividend income**

Dividend income is recognised when the right to receive payment is established. This is when the Board of ALD Automotive Limited approves the dividend based on the entity's statutory results.

#### 2. OPERATING PROFIT/LOSS

Auditor's remuneration is borne by ALD Automotive Limited, a subsidiary of the Company.
