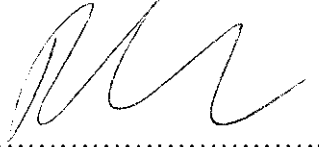

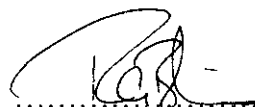
ELECTIVE RESOLUTIONS

 - (c) to dispense with the obligation to appoint auditors annually in accordance with Section 386.
