

ORDER

UPON THE PETITION of The Collins Partnership Limited ("the Company") whose registered office is situate at RSM Robson Rhodes, 2-4 Cayton Street, London, EC1V 9EH presented to the court on 23rd June 2005 by Kevin John Hellard and Kevin Ashley Goldfarb, the joint administrators of the Company ("the Administrators")

AND UPON hearing Solicitor Advocate for the Administrators

AND UPON READING the evidence in the Witness Statement and exhibit of Kevin John Hellard dated 22nd June 2005

AND UPON THE COURT BEING SATISFIED on the evidence before it that Council Regulation (EC) No. 1346/2000 of 29 May 2000 on Insolvency Proceedings ("the EC Regulation") does apply to these proceedings and that these are main proceedings as defined in Article 3 of the EC Regulation.

IT IS ORDERED that

1. The Administration Order made by Mr Justice Lloyd in the High Court of Justice on 12 March 2002 be discharged pursuant to section 18 of the Insolvency Act 1986 ("the Act")
2. Kevin John Hellard, Kevin Ashley Goldfarb and John Samuel Francis Bennett, be released forthwith from all liability pursuant to section 20 of the Act

3. The requirements for advertisement of the winding up petition imposed by the Insolvency Rules 1986 Rules 4.7(a), 4.22(4) and 4.23(1) be dispensed with
4. The Company be wound up by the Court under the provisions of the Act
5. Kevin John Hellard and Kevin Ashley Goldfarb be appointed as Joint Liquidators pursuant to section 140 of Act
6. Any act required or authorised under any enactment to be done by a liquidator may be done by any one or more of the persons for the time being holding the office of liquidator
7. These proceedings be Main Proceedings as defined in Article 3 of the EC Regulation
8. The costs of this Petition be in the liquidation.
