Accounting policies

1.1 Legal form

Alcohols (North West) Limited is a private limited company incorporated in England and Wales. The address of the company's principal place of business is 3rd Floor Endeavour House, Coopers End Road, Stansted, Essex, CM24 1SJ. Details of the principal activity of the company are included in the directors' report on page 1.

1.2 Basis of preparation of financial statements
