The management committee presents its report and financial statements of the company for the above period. The company is limited by guarantee without a share capital and is also a registered Charity No: 1052876.



1. STATUS OF COMPANY

The company is limited by guarantee of the members. In terms of paragraph 6 of the Memorandum of Association, every member of the company is liable to contribute, in the event of winding up, such amount as may be required, not exceeding £1.00.

2. TAXATION

The Company is exempt from Corporation Tax under Section 505 Income and Corporation Taxes Act 1988.

3. OPERATIONAL EXPENSES

These are made up of all purchase made by the association with regard to : office equipment, decorating, maintenance, special events, etc.

4. DIRECTORS, EMPLOYEES AND STAFF COSTS

There were no employees during the last year. The directors are not employed by the company and receive no remuneration for their services to the company.
