Report of the Directors (Incorporating the Trustees' Report) For the year ended 31 March 2007

Introduction

The Trustees present their annual report and the audited financial statements for the year ended 31 March 2007. In preparing this report the Directors have complied with current statutory requirements, the Accounting and Reporting by Charities Statement of Recommended Practise (Revised 2005) ('SORP'), applicable accounting standards and the requirements of the charity's governing document

Reference and administration information

On 13 March 2007, Symphony Hall (Birmingham) Limited was renamed Performances Birmingham Limited ('PBL') PBL leases and operates Town Hall and Symphony Hall in Birmingham

PBL is registered with the Charity Commission for England and Wales under number 1053937. The charity is registered with Companies House for England and Wales under number 3169600. The Trustees and senior executives of the charity are listed on page 23. Principal places of business and professional advisers of the charity are given on page 24.

On 8 June 2000 the National Exhibition Centre Limited granted the charity a sub-lease covering Symphony Hall itself, associated foyers and bar areas. The lease is effective from 1 April 1996 and runs for 30 years, with the charity having an option to extend the lease for a further 10 years.

On 9 February 2007 the charity entered into a Tenancy at Will for Town Hall, Birmingham with Birmingham City Council A long-term lease is being negotiated with Birmingham City Council for Town Hall

Structure, Governance and Management

Organisational structure

The company is Limited by Guarantee, with the National Exhibition Centre Limited as its sole member. It is governed by a memorandum and articles of association that were last amended on 29 June 2006.

The charity has been registered as an educational charity to educate the public by encouraging appreciation of the arts, in particular music, and to educate young people in performing and composing music

The charity continues to hold the whole of the issued share capital of Performances Birmingham (Enterprises) Limited ('PBEL') (Formerly named Symphony Hall (Enterprises) Limited, named changed on 13 March 2007) PBEL is registered with Companies House for England and Wales under number 3146280 PBEL is governed by its memorandum and articles of association adopted on 5 January 1996

Governance

The governing body of PBL is the Board of Trustees The Board consists of 12 Trustees who appoint a Chairman The Board are legally responsible for the governance and management of the charity

The Trustees are nominated by the Board and are made up of individuals chosen to represent the charity's stakeholders. They have a wide-ranging experience in business, music, education, and media and advise on all aspects of the charity's operation, giving strategic guidance on future development.

The charity is currently undertaking a review of its governance following enactment of agreed changes to the charity's memorandum and articles of association during 2007/08, and aims to develop a more structured and formal approach for the appointment of future Trustees

The Trustees recognise that a more formal approach should also be taken in respect of the induction and training of existing and new Trustees and will introduce enhanced procedures to replace the present informal induction process

Management

The Trustees are responsible for setting strategies and policies and for ensuring that these are implemented. To assist with this work the Trustees have one Sub-Group of the Board and an Advisory Group. Details of their membership is disclosed on page 23.

Authority to conduct the day-to-day operations of the charity is delegated by the Trustees to the Director, Town Hall & Symphony Hall is accountable to the Board of Trustees and is responsible for the efficient running of both Town Hall and Symphony Hall with the help of his staff. The Director, Town Hall & Symphony Hall is responsible for the implementation of policies and strategies on behalf of the Trustees.

Finance & General Purposes Sub-Group

The Finance & General Purposes Sub-Group meets at least four times a year and its primary responsibility is to advise the Trustees on their duty to ensure all assets of the charity are properly safeguarded, managed and used and that funds are spent effectively and efficiently in the course of its activities

The Sub-Group also advises the Trustees on the financial strategy of the charity and the performance against the strategy, undertakes a review of the effectiveness of internal financial controls and risk management systems, reviews the effectiveness of the charity's internal audit function and the clarity and completeness of disclosures in the financial statements

Education Advisory Group

Performances Birmingham is committed to delivering the highest standards in its education programme. The Education Advisory Group, provides a mechanism for ongoing evaluation, review and enhancement of the education programme. The group advises the Education Manager on an annual draft education plan, monitors progress towards agreed objectives during the course of the year, evaluates progress at the year-end (informing the following year's plan), and regularly evaluates specific projects (or nominates others to do so where appropriate)

Risk management

The management, who advise the Trustees, actively review the major risks that the charity faces on a regular basis, with a continuous review of the controls over key financial systems carried out through an internal audit programme. The management have also examined other operational and business risks and confirm that they have established systems to mitigate significant risks.

Liquidity risk

The charity's policy is to ensure continuity of available funding by active management of working capital

Credit Risk

The charity has no significant concentrations of credit risk. The charity has implemented policies that require appropriate credit checks on potential customers before sales commence.

Objectives and activities

Objectives

The charity's general aims continue to be those that are in fulfilment of its charitable objects as stated within its memorandum and articles. Broadly summarised, these are

- (a) to promote and present concert performances of classical, popular, and contemporary music, complementary to those of the City of Birmingham Symphony Orchestra (CBSO), and of world-class calibre, and
- (b) to educate the public by promoting, fostering, and encouraging the knowledge, understanding, and appreciation of the arts, particularly music, providing an education programme for this purpose

Report of the Directors (Incorporating the Trustees' Report) - continued

It is the charity's continuing aim to provide a facility of international standing for rehearsal and performances by the CBSO and other local music groups (both professional and amateur) from the City of Birmingham and surrounding region. More broadly, in striving for excellence in all aspects of work, the charity aims to consolidate the City of Birmingham's international reputation for musical excellence.

Activities during the year, Achievements and Performance

Overview

2006/07 has been an exciting yet challenging year for the charity. The amount of change the charity has successfully implemented over the year is a reflection of both the strength and support the charity holds from its wide constituency of stakeholders. During the year the charity rolled out an exciting new brand identity, changed the company name Symphony Hall (Birmingham) Limited to Performances Birmingham Limited ('PBL') and revised its staffing organisation structure. This was all necessitated by the future vision and operating plans that the charity is working towards to effectively manage and programme both Town Hall and Symphony Hall on a combined and complementary basis in furtherance of PBL's charitable aims and objectives. This is the most exciting time to date in the charity's 11 year history and it is anticipated that it will allow considerable development of the charity's work in all areas.

As highlighted in the 'Plans for future periods' section (page 8), the charity is considering a change in membership status. The charity has received notification from the National Exhibition Centre Limited ('NEC') that it wishes to stand down as the sole member of the charity. As part of this likely membership change the charity has initiated a series of administrative, operational and management changes to ensure that it is able to legally operate on a stand-alone basis following any proposed membership transfer. These administrative, operational and management changes included establishing stand alone accounting records and databases, preparing Service Level Agreements with NEC Ltd for both services supplied and formalising future operational arrangements. The Charity Commission's consent to the proposed arrangements has also been sought. 2006/07 was the first year by which the charity received its main source of funding direct from Birmingham City Council, rather than via NEC.

In terms of activity, within Symphony Hall 356,000 people attended 305 paid concerts and education events this year, with an average paid attendance of 1,140. Overall, taking into account both paid and unpaid events and the busy programme of educational tours and workshops (which do not show in these figures), Symphony Hall remains one of the busiest halls in the country.

Breaking down the programme, Symphony Hall promoted 42 concerts in its prestigious International Concert Series and hosted 75 concerts and 19 free-standing rehearsals (i.e. not preceding a concert) by the CBSO, its resident orchestra. The Hall promoted and co-promoted some 81 other concerts, across a range of light classical, jazz and big-band, pop, country and world music, as well as a small number of stand-up comedy shows and other speech events. There were 15 organ concerts (evening and lunchtime) and 10 Sunday morning coffee concerts, with 8 recording and other sessions.

There were 8 major educational events (large-scale events, as opposed to workshops and projects) as well as a host of smaller activities. Interwoven into the main concert programme, throughout the year Symphony Hall also offers a crowded programme of events for schools and young people, including master classes, pre-concert talks for A-level and GCSE music students, school-based workshops and assemblies, teacher INSET days, work experience placements, hall tours, and public tours.

Part of the Hall's remit is to provide a showcase facility for local organisations, and the Hall was hired by local users for 32 events, including a range of musical events, graduation ceremonies, the Faraday lectures, and charity fundraising concerts

The Concert Programme

Symphony Hall's International Concert Series remains the flagship of the Hall's own-promoted classical concerts, bringing outstanding international orchestras and soloists to Birmingham to complement the work of the CBSO, our resident orchestra Thanks to the support of Birmingham City Council, the International Concert Series makes a major contribution to cultural life outside London, and maintains loyal audiences

The financial year opened in mid-series Spring and early summer 2006 saw outstanding concerts by Cecilia Bartoli and the Freiburg Baroque Orchestra, alongside recitals by Andreas Schiff, Tasmin Little, and Håkan Hardenberger Cementing Symphony Hall's close links with Valery Gergiev, the outstanding event of the period was a Mariinsky Masterworks miniresidency with the forces of his Kirov Opera. The Kirov Orchestra opened the week with a memorable Shostakovich Centenary Concert. Three operas in concert followed, all with strong links to St Petersburg. Tchaikovsky's Eugene Onegin, Verdi's Forza del Destino, and a rare performance of Rimsky-Korsakov's massive opera-ballet Mlada. Contrasting with all this operation.

splendour, the Kirov Opera Chorus took centre stage for an evening to give a magical performance of Rachmaninov's Vespers, the supreme masterpiece of the Russian orthodox choral tradition

June 2006 saw a celebration of Sir Charles Mackerras's 80th Birthday with the Philharmonia Orchestra, and the anniversary theme continued into the 2006/07 International Season with concerts celebrating the 150th anniversary of Elgar's birth (conducted by Sir Andrew Davis) and the 50th anniversary of the death of Sibelius (featuring Finnish artists led by the conductor Osmo Vanska, perhaps the composer's greatest living exponent) in addition there was an evening of all six of Bach's Brandenburg Concertos directed by Trevor Pinnock to celebrate latter's 60th birthday, and a concert by Thomas Trotter and the CBSO to mark the fifth birthday of the Symphony Organ An innovative organ concert entitled Medieval to Messiaen commissioned visuals and an electro-acoustic score to accompany Ligeti's breathtaking Volumina and Messiaen's La Nativite de notre Seigneur. New visuals were also commissioned for a concert by the New York ensemble Bang on a Can All Stars, to accompany their performance of Brian Eno's ambient classic Music for Airports. Outside the International Concert Season, of course, Symphony Hall continues to present the UK's most substantial series of weekly lunchtime organ concerts, based at the Birmingham Cathedral (while the Town Hall is refurbished) three times a month and once a month at Symphony Hall

Other International Season highlights included the Royal Philharmonic Orchestra performing Mahler's epic Symphony of a Thousand, a return visit from the Orchestra of La Scala Milan, this time with the distinguished conductor Riccardo Chailly, and Birmingham's own Mendelssohn work, Elijah, performed by the Kings Consort. A special evening brought choral and orchestral forces directly from Bach's own church, St Thomas's in Leipzig, to perform his Mass in B minor. The pianist Andras Schiff concluded his survey (over three seasons) of all Beethoven's 32 piano sonatas, completing a marvellous piano series that included Evgeny Kissin, Lang Lang and Freddy Kempf. Other popular artists were Kiri Te Kanawa and Frederica von Stade (in duet), guitarist John Williams, flautist James Galway.

Complementary to the classical programme, Symphony Hall continues to present a rich and varied programme of high-profile and high-quality rock, pop, folk, world, jazz and comedy artists. Alongside the Hall's programme of local hires and free events, (such as the popular Rush Hour Blues concerts with Birmingham Jazz and veteran jazzer Andy Hamilton's monthly Sax in the City sessions), this programme mix ensures that the Hall attracts a diverse range of audiences of all sorts and is visited by an ever-wider proportion of the public. In a programme of over 100 non-classical concerts, particular highlights this year have included Morrissey, Chris Rea (with a performance filmed for DVD release), jazz legend Oscar Peterson, Senegalese musical maverick Cheik Lô with master kora player Toumani Diabate, Gladys Knight, country-rock singer Lucinda Williams, Paul Rodgers, Marti Pellow, Deacon Blue, Canadian singer-songwriter Ray LaMontagne, Hans Raj Hans in a concert of sufi singing, two sold-out nights with comedian Jimmy Carr, Craig David, Art Garfunkel, John Martyn, Brian Ferry and Buena Vista Social Club

The Education/Community Programme

During 2006/07, planning for education and community work took on a whole new dimension with the knowledge that in 2007/08 our work would be embracing Town Hall. New programme strands harnessing Town Hall's resources are starting to take shape, existing strands have been developed with a new focus in mind, and new partnerships and collaborations are bringing new ideas to the table.

In the mean time, project work at Symphony Hall has continued apace. Symphony Organ's fifth birthday was celebrated with a project involving 30 participants from City Road Primary School and St Clare's Primary School, Birmingham. After a behind-thescenes look at the Hall and an opportunity to play the Symphony Organ, the children spent their first workshop designing birthday cards for the organ. Music and design workshops provided the opportunity for them to learn about the instrument Each school was tasked with designing an organ sound-sculpture, and using multimedia software they children created an ambient composition, heard playing from within the sculptures when they were displayed at the Organ's Fifth Birthday concert.

In November, a primary-school concert called Stayin' Alive! used the organ as a centrepiece for a pantomime that promoted the message of healthy eating through music. The sold-out concert was preceded by a set of music and cooking pilot workshops developed with primary school teachers from Small Heath, and tested on 90 pupils.

Symphony Hall's School Singing Programme was given a face-lift as the department's new Singing Project Manager started work on the development of a city-wide singing plan, in partnership with Birmingham Music Service and the CBSO Choral Department. First steps were also taken in the provision of teacher training activities in Choral Conducting and Investigating Repertoire (as part of the Vocally Brum Festival, with Black Voices). Plans have been developed to commission a new choral work that will have an ever-lasting life, in that it will be performed year-on-year with a new movement song added and an old one taken away. The aim of the piece will to celebrate Birmingham's rich culture and heritage, and it will be dedicated to the memory of George Jonas, a former trustee of Performances Birmingham and the CBSO.

Work in the multi-media field continued to expand as the Patrick Musictech Studio was updated and refurbished. New project partners came on board and an expanding outreach programme began with workshops at St Thomas's Centre for the Child (the Father's Make Music project), Kingsmere Remand Unit, several Birmingham-based secondary schools, and the Virtual College Participants ranged from family members to self-excluded young people.

Last year's Destination Installation project was reworked into a new project that addresses the needs of newly-arrived and indigenous families based in the area of Edgbaston (ready for delivery next year) and work with young people centred around the delivery of BTEC related modules from the music technology syllabus. Students from Perry Beeches Secondary School also worked on a multimedia arts project where they explored the broad mediums of film and sound, producing three multimedia compositions that accompanied an ensemble performance at the end of the project.

Looking to the future, the combined resources of Patrick Musictech Studio and the stages of both Symphony Hall and Town Hall will enable the charity to undertake a new strand of activity that welcomes young people into both venues. A series of workshops, open rehearsals, performance and debating opportunities, consultation exercises, hands-on work experience, training, course modules, summer schools and instrumental tuition/careers advice are planned for the future, in collaboration with organisations such as the University of the First Age and Birmingham Association of Youth Centres

There have been fewer foyer exhibitions than usual this year, due to work on developing the Town Hall programme. But in November and December, a photographic exhibition called Positive Lives documented the impact of the global HIV and AIDs epidemic, offering extraordinary insights into the lives of those affected. The project was a collaboration between Symphony Hall, Concern Worldwide and the Terrence Higgins Trust.

In gratitude our core supporters

The Trustees of Symphony Hall gratefully acknowledge the continuing generous support of Birmingham City Council As well as providing core funding for the Hall, the City's subvention of the International Series enables the Hall to present the greatest international artists and orchestras to the people of the West Midlands. It has established Birmingham as the pre-eminent UK musical city outside London, a fact that continues to be acknowledged in national press reviews of the Hall's concerts. Subvention from Birmingham City Council enables £5 tickets to be available for every concert in the series, along with concessions for senior citizens, disabled patrons, wheelchair users, students, benefit recipients and groups

Financial Review

Responsibilities for the accounts and financial statements

The Charities Act 1993 and the rules of Performances Birmingham Limited require the Trustees to prepare financial statements for each financial year that provide a true and fair view of the state of affairs of the charity's financial activities during the year and of its financial position at the end of the year. In preparing those financial statements, the Trustees are required to

- Select suitable accounting policies and then apply them consistently,
- Make judgements and estimates that are reasonable and prudent,
- · State whether applicable accounting standards have been followed, and
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will
 continue in operation

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy the financial position of the charity at any time and which ensure that the financial statements comply with applicable law and regulations. The Trustees are also responsible for safeguarding the assets of the charity and for their proper allocation under charity law, hence taking reasonable steps for the prevention and detection of fraud

In so far as the Trustees individually, are aware there is no relevant audit information of which the Company's auditors are unaware and the directors have taken all steps that they ought to have taken to make themselves aware of any relevant audit information and to establish that the auditors are aware of that information

Basis of accounting

The annual financial statements of PBL, which are attached to this report, have been prepared under the revised SORP

The opportunity has also been taken to review all PBL's key accounting policies to ensure that they continue to be in accordance with the requirements of the new SORP and of best accounting practice

Whilst the above steps have resulted in enhanced disclosures in the financial statements, it has not been necessary to make any significant amendments to key accounting policies

Review of the year

The results of the charity for the year are set out in the consolidated Statement of Financial Activities on page 12

The net income in the year for the group is £142,000 (2005/06) net expenditure £41,000)

Overall there were 305 events in 2006/07, which compares to 342 in 2005/06

The core grant from Birmingham City Council amounted to £2 522m (2005/06 £1 555m) and enables the charity to operate as a going concern

Expenditure in the year totalled £7 965m (2005/06 £7 823m) 99% of the expenditure relates to the delivery of the charity's objectives 1% of the total expenditure incurred in the year is incurred through activities related to generating funds. These include income-generating activities such as catering, sponsorship, and merchandising

Balance sheet

The balance sheet Funds mainly reflect the Organ asset as the residual value is to be depreciated over the assets remaining useful life. Other Funds held relate to the delivery of future Education and Community projects

Subsidiary undertakings

The charity's wholly owned subsidiary, Performances Birmingham (Enterprises) Limited ('PBEL'), continues to contribute to the charity's mission and its financial results are shown in note 20 to the consolidated accounts

PBEL continues to trade principally in the provision of catering services, and in the year has contributed £281,000 (2005/06 £406,000) to the charity's results

Investment policy and performance

The funds available for the charity to invest comprise advance box office receipts. In order to retain flexibility and availability of these funds, the charity utilises short -term, low risk financial markets treasury investments. No other investment vehicle is used

The charity's investments are also held as a means of earning revenue on designated and restricted funds until they are required

The yield in the year was 5 0% (2005/06 4 5%) and the investments had an average maturity of 49 days as at 31 March 2007

Reserves policy

The Unrestricted Fund relates to carrying out the charity's general objectives and the policy is to aim to have zero reserves against the General Reserve. Ultimately the Trustees believe the level of General Reserve should be maintained at a breakeven level and in any given year at no greater a deficit that can ultimately be covered by an agreed future funding profile indicated by the charity's core funder, Birmingham City Council

The charity's other Unrestricted funds categorised as being 'Designated' are in surplus to the value of £308,000 and relate to the education of visitors. The Trustees believe that the level of designated reserves held at year end March 2007 are appropriate and adequate for the charity, and equate to three months of discretionary charitable expenditure.

In relation to the charity's Restricted Fund, these contain donations from trusts, foundations and individuals to be used for specific charitable objectives. The majority of the Restricted Funds comprise donations received from the Organ Appeal, and is used to finance the annual depreciation cost. The excess of funding £100,000 (2005/06 £102,000) will be used to maintain and refurbish the instrument. The Trustees believe the level of Restricted Funds should always be maintained at a surplus level.

Insurances of Directors

The charity maintains insurance for the Trustees in respect of their duties as Directors of the charity

Employees

Performances Birmingham Limited does not employ any employees in its own name. The management team are seconded from the National Exhibition Centre Limited ('NEC') and the associated costs recharged to the charity. All temporary employees are employed by the NEC and the costs recharged to the charity.

Temporary employees are engaged on a daily basis from time to time as the fluctuations in the charity's business dictate

Plans for future periods

Town Hall, Birmingham

In October 2007 the charity plans to re-open Town Hall, Birmingham. The vision for Town Hall as a community venue is complementary with Symphony Hall, and it is the Trustees' intention that both venues will work together to

- identify and serve the needs of the multi-cultural population of the city
- provide a platform for local performers, amateur and professional, alongside a forward-looking programme of national and international performances and events
- provide a programme mix that engages past audiences and develops future ones
- create performance, participation and learning opportunities for young people
- engage all visitors with the Town Hall's heritage and its role in Birmingham's contemporary civic and cultural life
- make both venues welcoming and accessible to all, delivering a variety of cultural, community, civic and corporate
 activities to the highest professional standards with outstanding customer service

Membership status

The charity has received notification from NEC, being its current sole member, that it wishes to stand down as the sole member of the charity. At the time of writing Trustees and senior management of the charity were considering the impact of this request which also involved discussions with its main funder Birmingham City Council.

Performances Birmingham Limited has already initiated a series of changes affecting the administrative, operational and management processes of the charity to ensure that the proposed membership change does not affect future operating arrangements from both a legal or charitable perspective

Auditors

A resolution to reappoint PricewaterhouseCoopers LLP as auditors to the charity will be proposed at the annual general meeting

Accounting policies

Basis of preparation of accounts

The financial statements have been prepared in accordance with the Statement of Recommended Practice "Accounting and Reporting by Charities" issued by the Charity Commissioners in October 2000 and revised March 2005 ("SORP"), applicable accounting standards and the Companies Act 1985

The consolidated financial statements, which show the results of the charity and its trading subsidiary Performances Birmingham (Enterprises) Limited, have been prepared under the historical cost convention. No separate income and expenditure account is presented for the charity as permitted by Section 230 of the Companies Act 1985.

Basis of consolidation

The Group's financial statements include the financial statements of the charity and its trading subsidiary, Performances Birmingham (Enterprises) Limited and have been prepared on a line by line basis

Incoming resources

Income is generally recognised on a receivable basis for generating funds but income generated from charitable activities is recognised at the point revenue and the costs associated with the delivery of the services can be reliably measured. It is measured at the fair value of the consideration received or receivable.

The specific bases used are as follows

- Voluntary income includes donations on a receivable basis
- Investment income is accounted for on a receivable basis
- Charitable activity, trading and merchandising income is accounted for when earned
- Grants are recognised when the entitlement to the grant is confirmed. Grants that provide core funding, or are
 of a general nature provided by government, are recorded as income from generated funds.

Resources expended

Expenditure is recognised when it is incurred and is reported gross of related income on the following bases

- Cost of generating funds comprises the costs associated with attracting voluntary income and the other costs
 of other income generation e.g. costs associated with provision of catering services
- · Charitable expenditure comprises direct expenditure including direct staff costs attributable to its activities
- Governance costs include those incurred in the governance of its assets and are associated with constitutional and statutory requirements
- Support costs include the central functions and they have been allocated against the concert programme in order to ensure transparency and consistent basis of reporting of the charity

Tangible fixed assets and depreciation

It is the charity's policy to capitalise the cost of major capital projects and to depreciate them over their estimated useful lives. As a matter of policy expenditure is capitalised on individual projects where that expenditure is more than £10,000 in total and it directly results in either

- · Generation of new economic benefit,
- Enhances the economic benefit generated from existing assets, or
- Substantially increases the economic life of existing assets

The cost of the Organ (Note 12), which comprise the acquisition and construction costs, is being depreciated and charged against the restricted fund over the term of the sub-lease (25 years) from the date of installation (20 October 2001). There have been no capital projects during the year under review.

Investments

Cash and cash equivalents are stated at cost. Listed investments are stated at market value

Accounting policies (Continued)

Stocks

Stocks are stated at the lower of cost and net realisable value

Operating leases

Rentals payable under operating leases are charged to the Statement of Financial Activities on the straight line basis over the lease term

Funds

Performances Birmingham Limited has designated funds which are unrestricted funds set aside for specific purposes by the Trustees and which would otherwise form part of the charity's other charitable funds

Other charitable funds are unrestricted funds that are available to carry out any of the charitable objectives of the charity

Restricted funds are funds that have restrictions imposed by donors and can only be applied for the particular purposes specified by donors
