During the year the Company was exempt from audit under Section 249AA of the Companies Act 1985 and the Members have not required the Company to obtain an audit of its accounts.

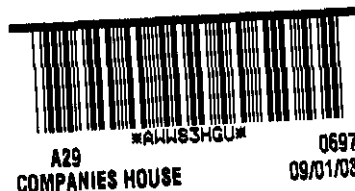
For the year ended 31 December 2002 the Company was entitled to exemption under section 249AA(1) of the Companies Act 1985.
