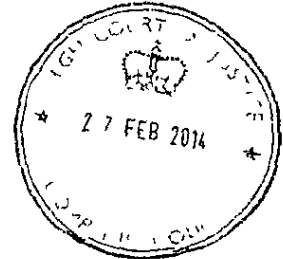

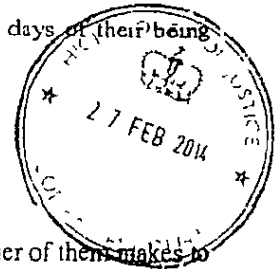
ORDER

IT IS ORDERED THAT
