



 - (1) the survival of the Company, and the whole or any part of its undertaking, as a going concern
 - (2) the approval of a voluntary arrangement under Part I of the Insolvency Act 1986
 - (3) a more advantageous realisation of the Company's assets than would be effected on a winding-up
