AND UPON READING the evidence

AND UPON HEARING Counsel for the Administrators

IT IS ORDERED that



- 1 the Administrators' terms of office in respect of the Companies are each extended up to and including 18 November 2010,
- 2 the Administrators may, if so advised, issue an application for a further extension of their terms of office such application to be issued no later than 4 weeks before 18 November 2010,
- 3 any application issued pursuant to paragraph 2 of this Order shall be considered in the first instance on paper by HH Judge Hodge QC unless he is not available in which case it shall be considered by HH Judge Pelling QC,
- 4 the content of the progress reports for the period ending 18 November 2009 shall be the same as that of the report drawn in support of the application provided that the Administrators shall write to creditors informing them of this order and of any material change between 16 October 2009 and 18 November 2009,
- 5 the costs of and occasioned by the application (including the legal costs thereof) shall be paid as expenses of the administrations of the Companies and divided equally between them
