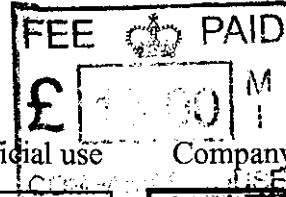



## Notes
