# Written Resolutions of Fairhold Freeholds No.2 Limited (the "Company")

## Background

À,

- (a) It is proposed that the Company enters into an amendment and restatement deed (the "Amendment Deed"), for the purpose of amending and restating a secured, term loan facility made available to the Company's parent, Dellmes GR Limited ("Dellmes") by Rothesay Life Limited ("Rothesay") pursuant to a facility agreement dated 9 March 2015 (the "Facility Agreement"), between, amongst others, itself (as an Original Guarantor), Dellmes (as Borrower) and Rothesay (as Arranger, Original Lender, Agent, Calculation Agent and Security Trustee)
- (b) It is a condition precedent to the Effective Date under the Amendment Deed that the holders of the Company's entire issued share capital pass the written resolutions noted below as special resolutions

#### Resolutions

Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 (the "Act"), it is proposed that the following special resolutions (the "Resolutions") be passed

- 1 THAT the terms of and the transactions contemplated by
  - (a) the Amendment Deed,
  - (b) a proposed amendment agreement to be entered into between, amongst others, the Company, Dellmes, Estates & Management Limited ("E&M") and Rothesay varying the terms of a duty of care agreement, dated 12 March 2015, entered into by, amongst others, the Company, Dellmes, E&M and Rothesay,
  - (c) an amendment and restatement agreement, amending and restating the terms of an intragroup loan agreement dated 12 March 2015, entered into by the Company, certain of its sister companies and Dellmes,
  - (d) a proposed contribution agreement to be entered into between the Company, certain of its sister companies and Dellmes pursuant to which it, and its sister companies that were a party to the contribution agreement, would agree to regulate the manner in which any claims made against them by Rothesay, under a guarantee granted by them pursuant to the Facility Agreement, would be dealt with as between themselves and to agree how any resulting liabilities would be apportioned between them, and
  - (e) any ancillary or related documents to the documents listed at paragraphs 1(a) to 1(d) (inclusive) above,

(together (the "Documents")), are hereby approved and that the entry into by the Company of the Documents will promote the success of the Company for the benefit of its members as a whole

2 THAT none of Christopher McGill, William Procter or Michael Watson who are directors of the Company as well as the other companies listed in the Schedule shall infringe his duty to avoid a situation in which he has, or can have, a direct or indirect interest that conflicts, or possibly may conflict, with the interests of the Company as a result of those other companies listed in the Schedule entering into or otherwise being interested in the Documents and/or the transactions contemplated thereby

- THAT notwithstanding any provisions of the memorandum or articles of association of the Company, for the purposes of the transactions contemplated by the Documents only, a director who is considered to have a conflict of interest with the Company may be counted as participating in a decision at a directors' meeting, or part of a directors' meeting, relating to it for quorum or voting purposes
- THAT each director and the company secretary be severally authorised to do any act, matter or thing, and to execute and deliver the Documents and any document, agreement, certificate, notice, communication or confirmation as is required or as they may approve or as they may deem necessary or desirable to be done or executed in connection with the Documents, or the transactions contemplated therein, and to approve any amendments or complete any details in relation to the Documents, that approval being conclusively evidenced by the execution or signature of the relevant Document
