## LEEK FINANCE HOLDINGS LIMITED (FORMERLY PUMASPRING LIMITED): NEW OBJECTS CLAUSE

- (A) (i) To invest in mortgage loans secured on residential or other properties within the United Kingdom or elsewhere and to acquire from third parties whether by purchase or otherwise mortgage loans and other similar investments; to lend or advance money and to give credit to any persons for any purpose whatsoever and in particular but without limitation for the purpose or purposes of, or in connection with, the acquisition, disposal or improvement of or alteration to any residential or other property or any interest therein within the United Kingdom or elsewhere, and whether secured on any such property or unsecured; to carry on business as money lenders, financiers and investors and to undertake and carry on all kinds of loan, financial and other operations.
  - (ii) To manage or administer the mortgage loan portfolios of local authorities or of any other persons in the United Kingdom or elsewhere and to manage or administer the businesses of any other third parties, whether or not within the United Kingdom, in whole or in part similar to any of the businesses of the Company.
  - (iii) To carry on any of the businesses of estate agents, conveyancers, surveyors, valuers, insurance brokers or any other business incidental to the acquisition, disposal or improvement of or alteration to any property or any interest therein; to carry on a consumer credit business within the meaning of the Consumer Credit Act 1974 (or any statutory amendment or reenactment thereof for the time being in force).
