

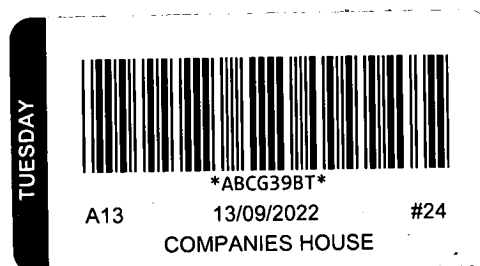




2) These accounts have been prepared in accordance with the provisions applicable to entities subject to the small companies regime.
