ACCOUNTING POLICIES

The following accounting policies have been used in dealing with items which are considered material in relation to the financial statements

Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards

Going concern

The company is party to a group funding structure. The directors are aware that the company's parent, Fairhold Services Limited, who is also party to that structure, has uncertainties in respect of its cash flows. These uncertainties are fully disclosed in the group accounts of Fairhold Services Limited. As a result of these uncertainties the directors have assessed the operation of the structure and have determined that the company has, or can expect to have, sufficient working capital for its needs for at least 12 months from the date of approval of these financial statements. In view of this the directors consider it appropriate for the financial statements to be prepared on a going concern basis.

Turnover

Turnover comprises management charges and administration fees receivable in respect of property management

Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date. Timing differences are differences between the company's taxable profits and its results as stated in the financial statements

Deferred tax is measured at the tax rates that are expected to apply in the periods in which timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantially enacted by the balance sheet date. An asset is not recognised to the extent that the transfer of economic benefit in future is uncertain. Deferred tax is measured on a non-discounted basis.

Cash flow statement

The company has taken advantage of the small company exemption from preparing a cash flow statement under the terms of Financial Reporting Standard 1

12 Related party transactions

The company has taken advantage of the exemptions provided by Financial Reporting Standard Number 8 'Related Party Disclosures' and has not disclosed transactions entered into between two or more members of a group, provided that any subsidiary undertaking which is party to the transaction is wholly owned by a member of that group

During the year the company made management charges totalling £7,761,020 (2009 £6,116,204) in respect of property management services provided to related party property owning companies, not covered by the exemption. These companies are related by virtue of common directors and/or common control, and fall under the ultimate ownership of the Tchenguiz Family Trust.
