

## MEMORANDUM OF ASSOCIATION

**OF** 

### ANNINGTON RECEIVABLES LIMITED

(As amended by a special resolution of 18 September 1996 and a special resolution of 7 October 1996.)

- 1. The Company's name is "ANNINGTON RECEIVABLES LIMITED".
- 2. The Company's registered office is to be situated in England and Wales.
- 3. The objects of the Company are:
- (a) (i) to undertake and perform the office and duties of trustee, for any person or corporation;
  - (ii) to undertake and execute any trust or discretion, and the distribution amongst the beneficiaries or other persons entitled to it, or any income, capital or other moneys, and whether in money or specie in furtherance of any discretion, obligation or permission;
  - (iii) for the above purposes to hold, deal with, invest, manage, direct the management of, buy sell, exchange, mortgage, charge, lease, dispose of or grant any right or interest in, over or upon any real or personal property of any kind, including contingent and reversionary interests in any property, and to undertake and carry on any business undertaking or transaction; and
  - (iv) in the matters and for the purposes aforesaid to act solely or jointly with any other person, corporation or body.

Pursuant to a special resolution passed on 18 September 1996 the name of the Company was changed from TACTICTHERMO LIMITED to ANNINGTON RECEIVABLES LIMITED.

- (b) To acquire and assume any estate or interest in and to take options over, construct, develop or exploit any property, real or personal, and rights of any kind and the whole or any part of the undertaking, assets and liabilities of any person and to act and carry on business as a holding Company.
- (c) To lend money, and grant or provide credit and financial accommodation, to any person and to deposit money with any person and to carry on the business of a banking, finance or insurance company.
- (d) To invest money of the Company in any investments and to hold, sell or otherwise deal with such investments, and to carry on the business of an investment company.
- (e) To borrow and raise money and accept money on deposit and to secure or discharge any debit or obligation in any manner and in particular (without prejudice to the generality of the foregoing) by mortgages or charges upon all or any part of the undertaking, property and assets (present and future) and uncalled capital of the Company or by the creation and issue of securities.
- (f) To enter into any guarantee, interest rate exchange transaction, contract for difference, contract of indemnity or suretyship and in particular (without prejudice to the generality of the foregoing) to guarantee, support or secure, with or without consideration, whether by personal obligation or by mortgaging or charging all or any part of the undertaking, property and assets (present and future) and uncalled capital of the Company or by both such methods or in any other manner, the performance of any obligations or commitments of, and the repayment or payment of the principal amounts of and any premiums, interest, dividends and other moneys payable on or in respect of any securities or liabilities of any person including (without prejudice to the generality of the foregoing) any company which is for the time being a subsidiary or a holding company of the Company or another subsidiary of a holding company of the Company or otherwise associated with the Company.
- (g) To accept, draw, make, create, issue, execute, discount, endorse, negotiate and deal in bills of exchange, promissory notes, and other instruments and securities whether negotiable or otherwise.
- (h) To provide services of all descriptions and to carry on business as advisers, consultants, brokers and agents of any kind.
- (i) To advertise, market and sell any products or services of the Company and of any other person and to carry on the business of advertisers or advertising agents or of a marketing and selling organisation or of a supplier, wholesaler, retailer, merchant or dealer of any kind.

- (j) To acquire and carry on any business carried on by a subsidiary or a holding company of the Company or another subsidiary of a holding company of the Company.
- (k) To apply for and take out, purchase or otherwise acquire any trade and service marks and names, designs, patents, licences, intellectual property rights, patent rights, inventions and secret processes.
- (l) To sell, exchange, mortgage, charge, let, grant licences, easements, options, servitudes and other rights over, and in any other manner deal with or dispose of, all or any part of the undertaking, property and assets (present and future) of the Company for any consideration and in particular (without prejudice to the generality of the foregoing) for any securities or for a share of profit or a royalty or other periodical or deferred payment.
- (m) To issue and allot securities of the Company for cash or in payment or part payment for any real or personal property purchased or otherwise acquired by the Company or any services rendered to the Company or as security for any obligation or amount (even if less than the nominal amount of such securities) or for any other purpose.
- (n) To give any remuneration or other compensation or reward for services rendered or to be rendered in placing or procuring subscriptions of, or otherwise assisting in the issue of any securities of the Company or in or about the formation of the Company or the conduct or course of its business, and to establish or promote, or concur or participate in establishing or promoting, any company, fund or trust and to subscribe for, underwrite, purchase or otherwise acquire securities of any company, fund or trust, and to act or director of and as secretary, manager, registrar or transfer agent for any other company and to act as trustee of any kind and to undertake and execute any trust and any trust business.
- (o) To pay all the costs, charges and expenses preliminary or incidental to the promotion, formation, establishment and incorporation of the Company, and to procure the registration or incorporation of the Company in or under the laws of any place outside England.
- (p) To grant or procure the grant of donations, gratuities, pensions, annuities, allowances, or other benefits, including benefit on death to any directors, officers or employees or former directors, officers or employees of the Company or any company which at any time is or was a subsidiary or a holding company of the Company or otherwise associated with the Company or any predecessor in business of any of them, and to the relations, connections or dependants of any such persons, and to other persons whose service or services have directly or indirectly been of benefit to the Company or whom the Board of Directors of the

Company considers have any moral claim on the Company or to their relations, connections or dependent and to establish or support any funds, trusts, insurances or schemes or any associations, institutions, clubs, schools, building and housing schemes, funds and trusts, and to make payments towards insurances or other arrangements likely to benefit any such persons or otherwise advance the interests of the Company or of its members, and to subscribe, guarantee or pay money for any purpose likely, directly or indirectly, to further the interests of the Company or of its members or for any national, charitable benevolent, educational, social, public, general or useful object.

- (q) To cease carrying on or wind up any business or activity of the Company, and to cancel any registration of and to wind up or procure the dissolution of the Company in any state or territory.
- (r) To distribute any of the property of the Company among its creditors and Members in specie or kind.
- (s) To do all or any of the things or matters aforesaid in any part of the world and either as principals, agents, contractors, trustees or otherwise and by or through trustees, agents or otherwise and either alone or in conjunction with others.
- (t) To carry on any other business or activity and do anything of any nature which in the opinion of the Board of Directors of the Company is or may be capable of being conveniently carried on or done in connection with the above, or likely directly or indirectly to enhance the value of or render more profitably all or any part of the Company's undertaking property or assets or otherwise to advance the interests of the Company or of its Members.
- (u) To do all such other things as in the opinion of the Board of Directors of the Company are or may be incidental or conducive to the attainment of the above objects of any of them.

And it is hereby declared that "company" in this clause, except where used in reference to the Company, shall include any partnership or other body of persons, whether incorporated or not incorporated, and whether formed, incorporated, domiciled or resident in the United Kingdom or elsewhere, "person" shall include any company as well as any other legal or natural person, "securities" shall include any fully, partly or nil paid or no par value share, stock, unit, debenture, debenture or loan stock, deposit, receipt, bill, note, warrant, coupon, right to subscribe or convert, or similar right or obligation, "and" and "or", shall mean "and/or" where the context so permits "other" and "otherwise" shall not be construed ejusdem generis where a wider construction is possible, and the objects specified in the different paragraphs of this clause shall not, except where the context expressly so requires, be in any way limited or

restricted by reference to or inference from the terms of any other paragraph or the name of the Company or the nature of any business carried on by the Company, but may be carried out in as full and ample a manner and shall be construed in as wide a sense as if each of the said paragraphs defined the objects of a separate, distinct and independent company.<sup>2</sup>

- 4. The liability of the Members is limited.
- 5. The Company's share capital is £1,000 divided into 1,000 shares of £1 each.

Pursuant to a special resolution passed on 7 October 1996 a new clause 3. was adopted and the previous clause 3. was deleted in its entirety.

# ARTICLES OF ASSOCIATION

of

#### ANNINGTON RECEIVABLES LIMITED

### PRELIMINARY

- The regulations in Table A in the Companies (Tables A-F) Regulations Table A 1. in force at the date of the incorporation of the Company shall not apply to the Company.
- 2. Interpretation In these Articles, except where the subject or context otherwise requires;

Act means The Companies Act 1985 including any modification or reenactment thereof for the time being in force.

Articles means these articles of association as altered from time to time by special resolution.

auditors means the auditors for the time being of the Company.

the board means the directors or any of them acting as the board of directors of the Company.

clear days means the period excluding the day when a notice is given or deemed to be given and the day for which it is given or on which it is to take effect.

Companies Acts has the meaning ascribed thereto by section 744 of the Act and any enactment passed after those Acts which may, by virtue of that or any other such enactment, be cited together with those Acts as the "Companies Acts" (with or without the addition of an indication of the date of any such enactment).

director means a director of the Company.

dividend means Dividend or bonus.

holder means in relation to any shares the member whose name is entered in the register as the holder of such shares.

member means a member of the Company.

**Memorandum** means the memorandum of association of the Company as amended from time to time.

office means the registered office of the Company.

paid means paid or credited as paid.

the register means the register of members of the Company.

the seal means the common seal of the Company and includes any official seal kept by the Company by virtue of section 39 or 40 of the Act.

the secretary means the secretary of the Company and includes a joint, assistant, deputy or temporary secretary and any other person appointed to perform the duties of the secretary.

United Kingdom means Great Britain and Northern Ireland.

3. References to a document being executed include references to its being Construction executed under hand or under seal or by any other method.

References to writing include references to any visible substitute for writing and to anything partly in one form and partly in another form.

Words denoting the singular number include the plural number and vice versa; words denoting the masculine gender include the feminine gender; and words denoting persons include corporations.

Save as aforesaid any words or expressions defined in the Act (but excluding any statutory modification thereof not in force at the date of adoption of these Articles) shall, if not inconsistent with the subject or context, bear the same meaning in these Articles.

Subject to the preceding paragraph, references to any provision of any enactment or of any subordinate legislation (as defined by section 21(1) of the Interpretation Act 1978) include any modification or re-enactment of that provision for the time being in force.

Headings are inserted for convenience only and do not affect the construction of these Articles.

In these Articles, (a) powers of delegation shall not be restrictively construed but the widest interpretation shall be given thereto; (b) the word board in the context of the exercise of any power contained in these Articles includes any committee consisting of one or more directors, any director and any manager or agent of the Company to which or, as the case may be, to whom the power in question has been delegated; (c) no power of delegation shall be limited by the existence or, except where expressly provided by the terms of delegation, the exercise of that or any other power of delegation; and (d) except where expressly provided by the terms of delegation, the delegation of a power shall not exclude the concurrent exercise of that power by any other body or person who is for the time being authorised to exercise it under these Articles or under another delegation of the power.

#### SHARE CAPITAL

- The share capital of the Company on the adoption of these Articles is 4. £1,000 divided into one thousand ordinary shares of £1 par value each.
- 5. Subject to the provisions of the Companies Acts and without prejudice Shares with to any rights attached to any existing shares or class of shares, any share may be issued with such rights or restrictions as the Company may by ordinary resolution determine or, subject to and in default of such determination, as the board shall determine.

Subject to the provisions of the Companies Acts, all unissued shares for Allotment the time being in the capital of the Company shall be at the disposal of the board, and the board has general and unconditional authority to allot (with or without conferring a right of renunciation), grant options over, offer, or otherwise deal with or dispose of them to such persons, on such terms and conditions, and at such times as the board thinks fit.

- The directors have general and unconditional authority, pursuant to section 80 of the Companies Acts, to exercise all powers of the Company to allot relevant securities for a period expiring on the fifth anniversary of the date of adoption of these Articles unless previously, varied or revoked by the Company in general meeting.
- (c) The maximum amount of relevant securities which may be allotted pursuant to the authority conferred by paragraph 6(b) is the amount of the authorised but unissued share capital of the Company at the date of adoption of these Articles.
- By the authority conferred by paragraph 6(b), or by any renewal of the authority, the directors may before the authority expires make an offer or agreement which would or might require relevant securities to be allotted after it expires and may allot relevant securities in pursuance of that offer or agreement.

- 7. The pre-emption provisions of section 89(1) of the Companies Act do not apply to an allotment of the Company's equity securities.
- 8. Subject to the provisions of the Companies Acts, and without prejudice Redeemable to any rights attached to any existing shares or class of shares, shares may be issued which are to be redeemed or are to be liable to be redeemed at the option of the Company or the holder on such terms and in such manner as may be provided by these Articles.

9. The Company may exercise all powers of paying commissions or Commissions brokerage conferred or permitted by the Companies Acts. Subject to the provisions of the Companies Acts, any such commission or brokerage may be satisfied by the payment of cash or by the allotment of fully or partly paid shares or partly in one way and partly in the other.

Except as required by law, no person shall be recognised by the Trusts not 10. Company as holding any share upon any trust and (except as otherwise provided by these Articles or by law) the Company shall not be bound by or recognise any interest in any share (or in any fractional part of a share) except an absolute right to the entirety thereof in the holder.

### VARIATION OF RIGHTS

11. Subject to the provisions of the Companies Acts, if at any time the capital Method of of the Company is divided into different classes of shares, the rights attached to any class may (unless otherwise provided by the terms of issue of the shares of that class) be varied or abrogated, whether or not the Company is being wound up, either with the consent in writing of the holders of three-quarters in nominal value of the issued shares of the class or with the sanction of an extraordinary resolution passed at a separate general meeting of the holders of the shares of the class (but not otherwise).

varying rights

12. For the purposes of this Article, unless otherwise expressly provided by When rights the rights attached to any shares or class of shares, those rights shall be deemed to be varied be varied by the reduction of the capital paid up on those shares otherwise than by a purchase or redemption by the Company of its own shares and by the allotment of other shares ranking in priority for payment of a dividend or in respect of capital or which confer on the holders voting rights more favourable than those conferred by such first mentioned shares, but shall not otherwise be deemed to be varied by the creation or issue of other shares ranking pari passu with, or subsequent to, such first mentioned shares or by the purchase or redemption by the Company of any of its own shares.

### SHARE CERTIFICATES

13. Every member, upon becoming the holder of any shares, shall be Members' entitled, without payment, to one certificate for all the shares of each class held certificates

by him (and, upon transferring a part of his holding of shares of any class, to a certificate for the balance of such holding) or several certificates each for one or more of his shares upon payment for every certificate after the first of such reasonable sum as the board may from time to time determine. Every certificate shall specify the number, class and distinguishing numbers (if any) of the shares to which it relates and the amount or respective amounts paid up thereon and, where the Company has adopted a seal, sealed with the seal. The Company shall not be bound to issue more than one certificate for shares held jointly by several persons and delivery of a certificate to one joint holder shall be a sufficient delivery to all of them. Shares of different classes may not be included in the same certificate.

If a share certificate is defaced, worn out, lost or destroyed, it may be Replacement 14. renewed on such terms (if any) as to evidence and indemnity (with or without security) and payment of any exceptional out-of-pocket expenses reasonably incurred by the Company in investigating evidence and preparing the requisite form of indemnity as the board may determine but otherwise free of charge, and (in the case of defacement or wearing out) on delivery up of the old certificate.

certificates

#### LIEN

The Company shall have a first and paramount lien on every share (not Company to 15. being a fully paid share) for all moneys payable to the Company (whether shares presently or not) in respect of that share. The board may at any time (generally or in particular cases) waive any lien or declare any share to be wholly or in part exempt from the provisions of this Article. The Company's lien on a share shall extend to any amount (including dividends) payable in respect of it.

The Company may sell, in such manner as the board determines, any Enforcement of share on which the Company has a lien if a sum in respect of which the lien exists is presently payable and is not paid within fourteen clear days after notice has been given to the holder of the share or to the person entitled to it in consequence of the death or bankruptcy of the holder or otherwise by operation of law, demanding payment and stating that if the notice is not complied with the shares may be sold.

lien by sale

To give effect to any such sale the board may authorise some person to Giving effect to 17. execute an instrument of transfer of the shares sold to, or in accordance with the directions of, the purchaser. The transferee shall not be bound to see to the application of the purchase money nor shall his title to the shares be affected by any irregularity in or invalidity of the proceedings in relation to the sale.

The net proceeds of the sale, after payment of the costs, shall be applied Application of in or towards payment or satisfaction of so much of the sum in respect of which the lien exists as is presently payable, and any residue shall (upon surrender to the Company for cancellation of the certificate for the shares sold and subject to a

like lien for any moneys not presently payable as existed upon the shares before the sale) be paid to the person entitled to the shares at the date of the sale.

# CALLS ON SHARES

Subject to the terms of allotment, the board may from time to time make Power to make calls upon the members in respect of any moneys unpaid on their shares (whether in respect of nominal value or premium) and each member shall (subject to receiving at least fourteen clear days' notice specifying when and where payment is to be made) pay to the Company as required by the notice the amount called on his shares. A call may be required to be paid by A call may, before receipt by the Company of any sum due thereunder, be revoked in whole or part and the time fixed for payment of a call may be postponed in whole or part as the board may determine. A person upon whom a call is made shall remain liable for calls made upon him notwithstanding the subsequent transfer of the shares in respect whereof the call was made.

A call shall be deemed to have been made at the time when the Time when call 20. resolution of the board authorising the call was passed.

The joint holders of a share shall be jointly and severally liable to pay all Liability of 21. calls in respect thereof.

joint holders

If a call or any instalment of a call remains unpaid in whole or in part Interest payable 22. after it has become due and payable the person from whom it is due and payable shall pay interest on the amount unpaid from the day it became due and payable until it is paid at the rate fixed by the terms of allotment of the share or in the notice of the call or, if no rate is fixed, such rate, not exceeding 15 per cent. per annum or, if higher, the appropriate rate (as defined by the Act), as may be determined by the board, but the board may waive payment of such interest wholly or in part.

An amount payable in respect of a share on allotment or at any fixed date, Deemed calls 23. whether in respect of nominal value or premium or as an instalment of a call, shall be deemed to be a call duly made and notified and payable on the date so fixed or in accordance with the terms of the allotment, and if it is not paid the provisions of these Articles shall apply as if that amount had become due and payable by virtue of a call duly made and notified.

24. Subject to the terms of allotment, the board may make arrangements on Differentiation the issue of shares for a difference between the allottees and/or holders in the amounts and times of payment of calls on their shares.

calls in advance

25. The board may, if it thinks fit, receive from any member willing to Payment of advance the same all or any part of the moneys uncalled and unpaid upon any shares held by him and such payment in advance of calls shall extinguish pro tanto the liability upon the shares in respect of which it is made, and may pay upon all

or any of the moneys so advanced (until the same would but for such advance become presently payable) interest at such rate not exceeding (unless the Company by ordinary resolution may otherwise direct) 15 per cent. per annum or, if higher, the appropriate rate (as defined in the Act) as may be agreed upon between the board and such member.

#### FORFEITURE AND SURRENDER

If a call or any instalment of a call remains unpaid in whole or in part Notice 26. after it has become due and payable, the board may give to the person from payment of call whom it is due not less than formation of the payment of call whom it is due not less than fourteen clear days' notice in writing requiring payment of the amount unpaid together with any interest which may have accrued and any costs, charges and expenses incurred by the Company by reason of such non-payment. The notice shall name the place where payment is to be made and shall state that if the notice is not complied with the shares in respect of which the call was made will be liable to be forfeited.

If any such notice is not complied with, any share in respect of which it Forfeiture for 27. was given may, at any time before the payment required by the notice has been compliance made, be forfeited by a resolution of the board and the forfeiture shall include all dividends or other moneys payable in respect of the forfeited shares and not paid When any share has been forfeited, notice of the before the forfeiture. forfeiture shall be served upon the person who was before the forfeiture the holder of the share, and an entry of such notice having been given and of the forfeiture with the date thereof shall forthwith be made in the register opposite the entry of the share; but no forfeiture shall be invalidated by any omission or neglect to give such notice or to make such entries.

Subject to the provisions of the Companies Acts, a forfeited share shall be Sale of forfeited deemed to belong to the Company and may be sold, re-allotted or otherwise disposed of on such terms and in such manner as the board determines, either to the person who was before the forfeiture the holder or to any other person, and at any time before sale, re-allotment or other disposal, the forfeiture may be cancelled on such terms as the board thinks fit. Where for the purposes of its disposal a forfeited share is to be transferred to any person the board may authorise some person to execute an instrument of transfer of the share to that person. The Company may receive the consideration given for the share on its disposal and may register the transferee as holder of the share.

A person any of whose shares have been forfeited shall cease to be a Liability member in respect of them and shall surrender to the Company for cancellation forfeiture the certificate for the shares forfeited but shall remain liable to the Company for all moneys which at the date of forfeiture were presently payable by him to the Company in respect of those shares with interest thereon at the rate at which interest was payable on those moneys before the forfeiture or, if no interest was so payable, at such rate, not exceeding 15 per cent. per annum or, if higher, the appropriate rate (as defined in the Act) as the board may determine, from the

date of forfeiture until payment, but the board may waive payment wholly or in part or enforce payment without any allowance for the value of the shares at the time of forfeiture or for any consideration received on their disposal.

The board may accept the surrender of any share which it is in a position Surrender 30. to forfeit upon such terms and conditions as may be agreed and, subject to any such terms and conditions, a surrendered share shall be treated as if it had been forfeited.

The forfeiture of a share shall involve the extinction at the time of Extinction of 31. forfeiture of all interest in and all claims and demands against the Company in respect of the share and all other rights and liabilities incidental to the share as between the person whose share is forfeited and the Company, except only such of those rights and liabilities as are by these Articles expressly saved, or as are by the Companies Acts given or imposed in the case of past members.

A statutory declaration by a director or the secretary that a share has been Evidence of 32. duly forfeited or surrendered on a specified date shall be conclusive evidence of the facts stated in it as against all persons claiming to be entitled to the share and the declaration shall (subject to the execution of an instrument of transfer if necessary) constitute a good title to the share and the person to whom the share is disposed of shall not be bound to see to the application of the purchase money, if any, nor shall his title to the share be affected by any irregularity in, or invalidity of, the proceedings in reference to the forfeiture, surrender, sale, reallotment or disposal of the share.

# TRANSFER OF SHARES

33. The instrument of transfer of a share may be in any usual form or in any Form and other form which the board may approve and shall be signed by or on behalf of transfer the transferor and, unless the share is fully paid, by or on behalf of the transferee. An instrument of transfer need not be under seal.

The board may, in its absolute discretion and without giving any reason, Restrictions on 34. refuse to register the transfer of a share, whether or not it is a fully paid share.

35. If the board refuses to register the transfer, it shall within two months Notice of after the date on which the instrument of transfer was lodged with the Company register send to the transferee notice of the refusal.

The registration of transfers of shares or of transfers of any class of shares Suspension of 36. may be suspended at such times and for such periods (not exceeding thirty days in any year) as the board may determine.

No fee shall be charged for the registration of any instrument of transfer No fee payable on registration or other document relating to or affecting the title to any share.

The Company shall be entitled to retain any instrument of transfer which Retention of is registered, but any instrument of transfer which the board refuses to register shall be returned to the person lodging it when notice of the refusal is given.

# TRANSMISSION OF SHARES

If a member dies the survivor or survivors where he was a joint holder, Transmission 39. and his personal representatives where he was a sole holder or the only survivor of joint holders, shall be the only persons recognised by the Company as having any title to his interest; but nothing herein contained shall release the estate of a deceased member (whether a sole or joint holder) from any liability in respect of any share held by him.

A person becoming entitled to a share in consequence of the death or Elections 40. bankruptcy of a member or otherwise by operation of law may, upon such transmission evidence being produced as the board may properly require as to his entitlement, elect either to become the holder of the share or to have some person nominated by him registered as the transferee. If he elects to become the holder he shall give notice to the Company to that effect. If he elects to have another person registered, he shall execute an instrument of transfer of the share to that person. All the provisions of these Articles relating to the transfer of shares shall apply to any such notice or instrument of transfer as if it were an instrument of transfer executed by the member and the death or bankruptcy of the member or other event giving rise to the transmission had not occurred.

The board may at any time give notice requiring any such person to elect either to be registered himself or to transfer the share and if the notice is not complied with within sixty days the board may thereafter withhold payment of all dividends or other moneys payable in respect of the share until the requirements of the notice have been complied with.

A person becoming entitled to a share in consequence of the death or Rights of 42. bankruptcy of a member or otherwise by operation of law shall, upon such by transmission evidence being produced as the board may properly require as to his entitlement and subject to the requirements of Article 40, have the same rights in relation to the share as he would have had if he were the holder of the share, and may give a discharge for all dividends and other moneys payable in respect of the share, but he shall not, before being registered as the holder of the share, be entitled in respect of it to receive notice of or to attend or vote at any meeting of the Company or to receive notice of or to attend or vote at any separate meeting of the holders of any class of shares in the Company.

#### ALTERATION OF SHARE CAPITAL

43. The Company may by ordinary resolution:

Alterations permitted by ordinary resolution

- increase its share capital by such sum to be divided into shares of such (a) amount as the resolution prescribes;
- consolidate and divide all or any of its share capital into shares of larger (b) amount than its existing shares;
- subject to the provisions of the Companies Acts, sub-divide its shares, or (c) any of them, into shares of smaller amount than is fixed by the Memorandum and the resolution may determine that, as between the shares resulting from the sub-division, any of them may have any preference or advantage as compared with the others; and
- cancel shares which, at the date of the passing of the resolution, have not (d) been taken or agreed to be taken by any person and diminish the amount of its share capital by the amount of the shares so cancelled.
- All new shares shall be subject to the provisions of these Articles with New shares 44. reference to payment of calls, lien, forfeiture, transfer, transmission and Articles otherwise, and, unless otherwise provided by these Articles, by the resolution creating the new shares or by the conditions of issue, the new shares shall be unclassified shares.

Whenever as a result of a consolidation or sub-division of shares any Fractions 45. fractions arise, the board may settle the matter in any manner it deems fit and in particular may sell shares representing fractions to which any members would otherwise become entitled to any person (including, subject to the provisions of the Companies Acts, the Company) and distribute the net proceeds of sale in due proportion among those members, and the board may authorise some person to execute an instrument of transfer of the shares to, or in accordance with the directions of, the purchaser. The transferee shall not be bound to see to the application of the purchase moneys nor shall his title to the shares be affected by any irregularity in or invalidity of the proceedings in relation to the sale.

Subject to the provisions of the Companies Acts, the Company may by Power to 46. special resolution reduce its share capital, any capital redemption reserve and any share premium account in any way.

#### PURCHASE OF OWN SHARES

Subject to and in accordance with the provisions of the Companies Acts Power to 47. and without prejudice to any relevant special rights attached to any class of shares shares, the Company may purchase any of its own shares of any class (including redeemable shares) and, if it is a private company, make a payment in respect of the redemption or purchase of its own shares otherwise than out of distributable profits of the company or the proceeds of a fresh issue of shares, at any price (whether at par or above or below par), and so that any shares to be so

purchased may be selected in any manner whatsoever. Every contract for the purchase of, or under which the Company may become entitled or obliged to purchase, shares in the Company shall be authorised by such resolution of the Company as may be required by the Companies Acts and by an extraordinary resolution passed at a separate general meeting of the holders of each class of shares (if any) which, at the date on which the contract is authorised by the Company in general meeting, entitle them, either immediately or at any time later on, to convert all or any of the shares of that class held by them into equity share capital of the Company.

## GENERAL MEETINGS

48. All general meetings of the Company other than annual general meetings Types of shall be called extraordinary general meetings.

general meeting

49. The board shall convene and the Company shall hold general meetings as Annual general annual general meetings in accordance with the requirements of the Act.

All provisions of these Articles relating to general meetings of the Class meetings Company shall, mutatis mutandis, apply to every separate general meeting of the holders of any class of shares in the capital of the Company.

Subject to the provisions of Article 49, the board may call general Convening 51. meetings whenever and at such times and places as it shall determine and, on the meetings requisition of members pursuant to the provisions of the Companies Acts, shall forthwith proceed to convene an extraordinary general meeting in accordance with the requirements of the Companies Acts. If there are not within the United Kingdom sufficient directors to call a general meeting, any director or any member of the Company may call a general meeting.

### NOTICE OF GENERAL MEETINGS

An annual general meeting and an extraordinary general meeting called Period of 52. for the passing of a special resolution, elective resolution or a resolution appointing a person as a director shall be called by at least twenty-one clear days' notice. All other extraordinary general meetings shall be called by at least fourteen clear days' notice but a general meeting may be called by shorter notice if it is so agreed:

- (a) in the case of an annual general meeting, by all the members entitled to attend and vote thereat; and
- (b) in the case of any other meeting by a majority in number of the members having a right to attend and vote being a majority together holding not less than ninety-five per cent. in nominal value of the shares giving that right.

53. Subject to the provisions of these Articles and to any restrictions imposed Provision of on any shares, the notice shall be given to all the members, to all persons entitled to a share in consequence of the death or bankruptcy of a member, to each of the directors, to the auditors for the time being of the Company and if required under the Companies Acts, the former auditors of the Company.

54. The notice shall specify the time and place of the meeting and, in the Contents of case of special business, the general nature of such business. All business shall be deemed special that is transacted at an extraordinary general meeting and also all business that is transacted at an annual general meeting with the exception of:-

- (a) the declaration of dividends;
- (b) the consideration and adoption of the accounts and balance sheet and the reports of the directors and auditors and other documents required to be annexed to the accounts;
- (c) the appointment and re-appointment of directors;
- (d) the appointment of auditors where special notice of the resolution for such appointment is not required by the Companies Acts; and
- (e) the fixing of, or the determining of the method of fixing, the remuneration of the directors and/or auditors.

The notice shall, in the case of an annual general meeting, specify the meeting as such, and, in the case of a meeting to pass a special, extraordinary or elective resolution, specify the intention to propose the resolution as a special, extraordinary, or elective resolution, as the case may be.

The notice shall state with reasonable prominence that a member entitled to attend and vote at the meeting being called is entitled to appoint one or more proxies to attend and vote instead of him, and that a proxy need not also be a member.

55. The accidental omission to give notice of a meeting, or to send a form of Accidental proxy with a notice where required by these Articles, to any person entitled to give notice receive the same, or the non-receipt of a notice of meeting or form of proxy by any such person, shall not invalidate the proceedings at that meeting.

# PROCEEDINGS AT GENERAL MEETINGS

56. No business shall be transacted at any general meeting unless a quorum is Quorum present, but the absence of a quorum shall not preclude the choice or appointment of a chairman, which shall not be treated as part of the business of the meeting. Save as otherwise provided by these Articles, one person, if and for so long as the Company has only one member, and two persons, if and for so long as the Company has two or more members, entitled to vote upon the

business to be transacted, each being a member or a proxy for a member or a duly authorised representative of a corporation, shall be a quorum.

57. If such a quorum is not present within half an hour (or such longer time If quorum not as the chairman of the meeting may decide to wait) from the time appointed for the meeting, or if during a meeting such a quorum ceases to be present, the meeting, if convened on the requisition of members, shall be dissolved, and in any other case shall stand adjourned to such time and place as the chairman of the meeting may determine. If at the adjourned meeting a quorum is not present within fifteen minutes after the time appointed for holding the meeting, the meeting shall be dissolved.

The chairman, if any, of the board or, in his absence, any deputy Chairman 58. chairman of the Company or, in his absence, some other director nominated by the board, shall preside as chairman of the meeting, but if neither the chairman, deputy chairman nor such other director (if any) is present within half an hour after the time appointed for holding the meeting or is not willing to act as chairman, the directors present shall elect one of their number to be chairman. If there is only one director present and willing to act, he shall be chairman. If no director is willing to act as chairman, or if no director is present within half an hour after the time appointed for holding the meeting, the members present and entitled to vote shall choose one of their number to be chairman.

59. A director shall, notwithstanding that he is not a member, be entitled to Directors attend and speak at any general meeting and at any separate meeting of the speak holders of any class of shares in the Company.

The chairman may, with the consent of a meeting at which a quorum is Adjournments present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at an adjourned meeting other than business which might properly have been transacted at the meeting had the adjournment not taken place. meeting is adjourned for thirty days or more or for an indefinite period, at least seven Clear days' notice shall be given specifying the time and place of the adjourned meeting and the general nature of the business to be transacted. Otherwise it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.

61. If an amendment shall be proposed to any resolution under consideration Amendments but shall in good faith be ruled out of order by the chairman of the meeting, the proceedings on the substantive resolution shall not be invalidated by any error in such ruling. With the consent of the chairman of the meeting, an amendment may be withdrawn by its proposer before it is voted upon. In the case of a resolution duly proposed as a special or extraordinary resolution, no amendment thereto (other than a mere clerical amendment to correct a patent error) may in any event be considered or voted upon.

to resolutions

62. A resolution put to the vote of a general meeting shall be decided on a Methods of show of hands unless, before or on the declaration of the result of a vote on the show of hands or on the withdrawal of any other demand for a poll, a poll is duly demanded. Subject to the provisions of the Companies Acts, a poll may be demanded by:

- (a) the chairman of the meeting; or
- (b) at least two members present in person or by proxy having the right to vote at the meeting; or
- (c) any member or members present in person or by proxy representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
- (d) any member or members present in person or by proxy holding shares conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right,

and a demand by a person as proxy for a member shall be the same as a demand by the member.

63. Unless a poll is duly demanded a declaration by the chairman that a Declaration of resolution has been carried or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority and an entry to that effect in the minutes of the meeting shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against the resolution.

64. The demand for a poll may, before the poll is taken, be withdrawn but Withdrawal of only with the consent of the chairman and a demand so withdrawn shall not be poll taken to have invalidated the result of a show of hands declared before the demand was made. If the demand for a poll is withdrawn, the chairman or any other member entitled may demand a poll.

65. A poll shall be taken as the chairman directs and he may appoint Conduct of scrutineers (who need not be members) and fix a time and place for declaring the result of the poll. The result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.

In the case of an equality of votes, whether on a show of hands or on a Chairman's poll, the chairman shall be entitled to a casting vote in addition to any other vote he may have.

A poll demanded on the election of a chairman or on a question of When poll to 67. adjournment shall be taken forthwith. A poll demanded on any other question shall be taken either forthwith or at such time and place as the chairman directs

which the right to vote is to be exercised and in default the right to vote shall not be exercisable.

74. No objection shall be raised to the qualification of any voter except at the Objection to meeting or adjourned meeting or poll at which the vote objected to is tendered, and every vote not disallowed at such meeting shall be valid. Any objection made in due time shall be referred to the chairman whose decision shall be final and conclusive.

75. On a poll votes may be given either personally or by proxy. A member Supplementary entitled to more than one vote need not, if he votes, use all his votes or cast all voting the votes he uses in the same way.

### PROXIES AND CORPORATE REPRESENTATIVES

76. An instrument appointing a proxy shall be in writing under the hand of Appointment the appointor or his attorney or, if the appointor is a corporation, either under its common seal or the hand of a duly authorised officer, attorney or other person authorised to sign it.

The instrument appointing a proxy shall be executed by or on behalf of Form of the appointer and shall be in any form which is usual or which the directors may standard approve.

78. Delivery of an instrument appointing a proxy shall not preclude a Voting by member from attending and voting in person at the meeting or poll concerned. A member may appoint more than one proxy to attend on the same occasion.

79. The instrument appointing a proxy and (if required by the board) any Delivery of authority under which it is executed or a copy of the authority, certified notarially or in some other manner approved by the board, may be delivered to the office (or to such other place or to such person as may be specified or agreed by the board) before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to act or, in case of a poll taken subsequently to the date of the meeting or adjourned meeting, before the time appointed for the taking of the poll, and an instrument of proxy which is not so delivered shall be invalid. The board may at its discretion treat a faxed or other machine made copy of an instrument appointing a proxy as such an instrument for the purpose of this Article.

form of proxy

80. The instrument of proxy shall, unless the contrary is stated in it, deemed to confer authority to vote as the proxy thinks fit on any amendment of a resolution put to the meeting for which the proxy is given and on any resolution put to the meeting, whether or not notice of such resolution was given in the notice of meeting. The instrument of proxy shall, unless the contrary is stated therein, be valid as well for any adjournment of the meeting as for the meeting to which it relates.

Validity of form of proxy

Any corporation or corporation sole which is a member of the Company Corporate 81. may (in the case of a corporation, by resolution of its directors or other governing body or by authority to be given under seal or under the hand of an officer duly authorised by it) authorise such person as it thinks fit to act as its representative at any meeting of the Company or at any separate meeting of the holders of any class of shares. A person so authorised shall be entitled to exercise the same power on behalf of the grantor of the authority as the grantor could exercise if it were an individual member of the Company and the grantor shall for the purposes of these Articles be deemed to be present in person at any such meeting if a person so authorised is present at it.

A vote given or poll demanded by proxy or by the duly authorised Revocation of representative of a corporation shall be valid notwithstanding the previous determination of the authority of the person voting or demanding a poll unless notice of the determination was received by the Company at the office or at such other place at which the instrument of proxy was duly deposited at least 3 hours before the commencement of the meeting or adjourned meeting at which the vote is given or the poll demanded or (in the case of a poll taken otherwise than on the same day as the meeting or adjourned meeting) the time appointed for taking the poll.

# NUMBER OF DIRECTORS

Unless otherwise determined, the number of directors (other than Limits on 83. alternate directors) shall be not less than 2 but shall not be subject to any directors maximum in number.

By agreement amongst the shareholders, the directors and the Company, directors may be designated as A Directors or B Directors. Any such director may be appointed to act as a director of the Company, with such rights and powers as are conferred on him pursuant to such agreement.

#### APPOINTMENT AND RETIREMENT OF DIRECTORS

85. A member or members holding a majority in nominal value of the issued Appointment shares for the time being conferring the right to vote at general meetings of the majority company shall have power from time to time and at any time to appoint any shareholders person or persons as a director or directors and to remove from office any director howsoever appointed. Any such appointment or removal shall be effected by an instrument which shall be in writing and shall (except in the case of an appointment or removal by telex or a facsimile transmission of an appointment or removal otherwise complying with the requirements of this regulation) be executed by the member or members making the same or by their duly authorised attorneys or in such other manner as the directors may approve, and shall take effect upon such appointment or removal being deposited or received at the office or otherwise communicated to the company

not being more than thirty days after the poll is demanded. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll was demanded. If a poll is demanded before the declaration of the result of a show of hands and the demand is duly withdrawn, the meeting shall continue as if the demand had not been made.

No notice need be given of a poll not taken forthwith if the time and Notice of poll 68. place at which it is to be taken are announced at the meeting at which it is demanded. In any other case at least seven clear days' notice shall be given specifying the time and place at which the poll is to be taken.

Where for any purpose an ordinary resolution of the Company is Effectiveness of 69. required, a special or extraordinary resolution shall also be effective and where for any purpose an extraordinary resolution is required a special resolution shall resolutions also be effective.

special and extraordinary

Subject to the provisions of the Companies Acts, a resolution in writing Resolutions in 70. executed by or on behalf of each member who would have been entitled to vote upon it if it had been proposed at a general meeting at which he was present shall be as effectual as if it had been passed at a general meeting properly convened and held and may consist of several instruments in the like form each executed by or on behalf of one or more of the members.

### VOTES OF MEMBERS

Subject to any rights or restrictions attached to any shares, on a show of Right to vote 71. hands every member who is present in person or by proxy shall have one vote and on a poll every member present in person or by proxy shall have one vote for every share of which he is the holder.

In the case of joint holders of a share the vote of the senior who tenders a Votes of joint 72. vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders and for this purpose seniority shall be determined by the order in which the names of the holders stand in the register.

holders

A member in respect of whom an order has been made by any court or Member under 73. official having jurisdiction (whether in the United Kingdom or elsewhere) in matters concerning mental disorder may vote, whether on a show of hands or on a poll, by his receiver, curator bonis or other person authorised in that behalf appointed by that court or official, and any such receiver, curator bonis or other person may, on a poll, vote by proxy. Evidence to the satisfaction of the board of the authority of the person claiming to exercise the right to vote shall be deposited at the office, or at such other place as is specified in accordance with these Articles for the deposit of instruments of proxy, not less than 48 hours before the time appointed for holding the meeting or adjourned meeting at

No person shall be disqualified from being appointed or reappointed a Age limit 90. director, and no director shall be required to vacate that office, by reason only of the fact that he has attained the age of seventy years or any other age nor shall it be necessary by reason of his age to give special notice under the Companies Acts of any resolution.

91. A director shall not be required to hold any shares of the Company by No share way of qualification.

# **ALTERNATE DIRECTORS**

92. Unless agreed otherwise, any director (other than an alternate director) Power to may appoint any other director, or any other person who is willing to act, to be alternates an alternate director and may remove from office an alternate director so appointed by him.

An alternate director shall be entitled to receive notice of all meetings of Alternates the board and of all meetings of committees of the board of which his appointor receive notice is a member, to attend and vote at any such meeting at which his appointor is not personally present, and generally to perform all the functions of his appointor (except as regards power to appoint an alternate) as a director in his absence. It shall not be necessary to give notice of such a meeting to an alternate director who is absent from the United Kingdom.

A director or any other person may act as alternate director to represent Alternates more than one director, and an alternate director shall be entitled at meetings of more than one

the board or any committee of the board to one vote for every director whom he represents (and who is not present) in addition to his own vote (if any) as a director, but he shall count as only one for the purpose of determining whether a quorum is present.

95. An alternate director may be repaid by the Company such expenses as Expenses and might properly have been repaid to him if he had been a director but shall not of alternates in respect of his services as an alternate director be entitled to receive any remuneration from the Company except such part (if any) of the remuneration otherwise payable to his appointer as such appointer may by notice in writing to the Company from time to time direct. An alternate director shall be entitled to be indemnified by the Company to the same extent as if he were a director.

96. An alternate director shall cease to be an alternate director: Termination of appointment

- (a) if his appointor ceases to be a director;
- on the happening of any event which, if he were a director, would cause (b) him to vacate his office as director; or
- (c) if he resigns his office by notice to the Company.
- 97. Any appointment or removal of an alternate director shall be by notice to Method of the Company signed by the director making or revoking the appointment and and revocation shall take effect in accordance with the terms of the notice (subject to any approval required by Article 91) upon receipt of such notice at the office.

98. Save as otherwise expressly provided in these Articles, an alternate Alternate not director shall be deemed for all purposes to be a director and, accordingly, an agent appointor except where the context otherwise requires, references to a director shall be deemed to include a reference to an alternate director. An alternate director shall alone be responsible for his own acts and defaults and he shall not be deemed to be the agent of the director appointing him.

# POWERS OF THE BOARD

99. Subject to the provisions of the Companies Acts, the Memorandum and Business to be these Articles and to any directions given by special resolution, the business of board the Company shall be managed by the board which may exercise all the powers of the Company. No alteration of the Memorandum or Articles and no such direction shall invalidate any prior act of the board which would have been valid if that alteration had not been made or that direction had not been given. The powers given by this Article shall not be limited by any special power given to the board by these Articles and a meeting of the board at which a quorum is present may exercise all powers exercisable by the board.

# DELEGATION OF POWERS OF THE BOARD

The board may delegate any of its powers to any committee consisting of Committees of one or more directors. The board may also delegate to any director such of its powers as the board considers desirable to be exercised by him. delegation shall, in the absence of express provision to the contrary in the terms of delegation, be deemed to include authority to sub-delegate to one or more directors (whether or not acting as a committee) or to any employee or agent of the Company all or any of the powers delegated and may be made subject to such conditions as the board may specify, and may be revoked or altered. The board may co-opt on to any such committee persons other than directors, who may enjoy voting rights in the committee. The co-opted members shall be less than one-half of the total membership of the committee and a resolution of any committee shall be effective only if a majority of the members present are directors. Subject to any conditions imposed by the board, the proceedings of a committee with two or more members shall be governed by these Articles regulating the proceedings of directors so far as they are capable of applying.

The board may, by power of attorney or otherwise, appoint any person Agents 101. or persons to be the agent or agents of the Company for such purposes, with such powers, authorities and discretions (not exceeding those vested in the board) and on such conditions as the board determines, including authority for the agent or agents to delegate all or any of his or their powers, authorities and discretions, and may revoke or vary such delegation.

# DISQUALIFICATION AND REMOVAL OF DIRECTORS

102. The office of a director shall be vacated if: Disqualification

- he ceases to be a director by virtue of any provisions of the Companies (a) Acts or these Articles or he becomes prohibited by law from being a director: or

  - (i) he is admitted to hospital in pursuance of an application for admission for treatment under the Mental Health Act 1983 or, in Scotland, an application for admission under the Mental Health (Scotland) Act 1960; or
  - (ii) an order is made by a court having jurisdiction (whether in the United Kingdom or elsewhere) in matters concerning mental disorder for his detention or for the appointment of a receiver,

curator bonis or other person to exercise powers with respect to his property or affairs; or

- (d) (not being a director holding office as such for a fixed term) he resigns his office by notice to the Company; or
- he shall for more than six consecutive months have been absent without (e) permission of the board from meetings of the board held during that period and his alternate director (if any) shall not during such period have attended in his stead and the board resolves that his office be vacated;

- (d) shall not, by reason of his office, be accountable to the Company for any benefit which he derives from any such office or employment or from any such transaction or arrangement or from any interest in any such body corporate and no such transaction or arrangement shall be liable to be avoided on the ground of any such interest or benefit.

A document purporting to be a copy of a resolution, or the minutes of or an extract from the minutes of a meeting of the Company or the holders of any class of shares of the Company or of the board or any committee of the board that is certified as aforesaid shall be conclusive evidence in favour of all persons dealing with the Company upon the faith thereof that such resolution has been duly passed or, as the case may be, that such minutes or extract is a true and accurate record of proceedings at a duly constituted meeting.

#### DIVIDENDS

- (b) appropriate the sum resolved to be capitalised to the members or any class of members on the record date specified in the relevant resolution who would have been entitled to it if it were distributed by way of dividend and in the same proportions and apply such sum on their behalf either in or towards paying up the amounts, if any, for the time being unpaid on any shares held by them respectively, or in paying up in full unissued shares, debentures or other obligations of the Company of a nominal amount equal to that sum, and allot the shares, debentures or other obligations credited as fully paid to those members, or as they may direct, in those proportions, or partly in one way and partly in the other; but the share premium account, the capital redemption reserve, and any profits which are not available for distribution may, for the purposes of this Article, only be applied in paying up unissued shares to be allotted to members credited as fully paid;
- (c) make such provision by authorising the sale and transfer to any person of fractions to which any members would become entitled or may issue

fractional certificates or may resolve that the distribution be made as nearly as practicable in the correct proportion but not exactly so or may ignore fractions altogether or resolve that cash payments be made to any members in order to adjust the rights of all parties or otherwise as (in each case) the board determines where shares or debentures become, or would otherwise become, distributable under this Article in fractions;

#### ACCOUNTS

No member shall (as such) have any right of inspecting any accounting Rights to records or other book or document of the Company except as conferred by statute or authorised by the board or by ordinary resolution of the Company or order of a court of competent jurisdiction.

# NOTICES

Any notice to be given to or by any person pursuant to these Articles When notice shall be in writing except that a notice calling a meeting of the board need not in writing be in writing.

Any notice or other document may be served on or delivered to any Method of member by the Company either personally, or by sending it by post addressed to

the member at his registered address or by fax or telex to a number provided by the member for this purpose, or by leaving it at his registered address addressed to the member, or by any other means authorised in writing by the member concerned. #### INDEMNITY

Subject to the provisions of the Companies Acts but without prejudice to Indemnity to any indemnity to which a director may otherwise be entitled, every director or officers, etc. other officer or auditor of the Company shall be indemnified out of the assets of the Company against all costs, charges, losses, expenses and liabilities incurred by him in the execution or discharge of his duties or the exercise of his powers or otherwise in relation thereto, including (but without limitation) any liability incurred by him in defending any proceedings, whether civil or criminal, in which judgment is given in his favour (or the proceedings are otherwise disposed of without any finding or admission of any material breach of duty on his part) or in which he is acquitted or in connection with any application in which relief is granted to him by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Company.
