To propose a resolution as a Special Resolution

The motion - to amend the wording of the Objects clause of the **Charity as follows:**

Current wording:

The Company is established to provide young people under the age of 19 in Greater Manchester and the surrounding neighbourhood with facilities for recreation or other leisure time occupation in the interest of social welfare with the object of improving the condition of life such persons without distinction on the grounds of race, gender, ethnic origin or disability.

Proposed amended wording:

"The Company is established to provide people in Greater Manchester and the surrounding neighbourhood (with a primary focus on young people under the age of 19) with facilities for recreation or other leisure time occupation in the interest of social welfare with the object of improving the conditions of life of such persons without distinction on the grounds of race, gender, ethnic origin or disability."

This proposed amendment is intended to broaden the scope of the Charitable Objects to include people of all ages, whilst retaining a primary focus on our current beneficiaries.

The wording has been submitted to the Charity Commission for approval as recommended by the Commission, and prior written consent to the amendment has been granted.

On the basis of the information you have provided, I am pleased to be able to offer the approval of the Charity Commission to the proposed amendment to the Memorandum and Articles of Association of the company. In this respect clause 3 of the Memorandum of Association can be replaced with the following; -
