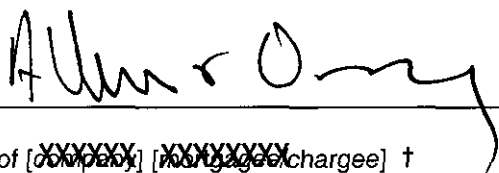

Pursuant to the terms of the Debenture, the Company as beneficial owner and with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994 as security for the payment, discharge and performance of all Secured Liabilities at any time owed or due to the Secured Parties (or any of them), charges in favour of the Security Agent (as agent and trustee for the Secured Parties):
 - (a) by way of a first legal mortgage all the property (if any) now belonging to it and specified in Schedule A to this Companies Form M395, together with all buildings and Fixtures thereon, the proceeds of sale of all or any part thereof and the benefit of any covenants for title given or entered into by any predecessor in title and any moneys paid or payable in respect of such covenants subject, in the case of any leasehold properties, to any necessary third party's consent to such mortgage being obtained (the charge in relation to any such leasehold property to take effect immediately on such consent being obtained);
 - (b) by way of first legal mortgage all estates or interests in any freehold or leasehold property and any rights under any licence or other agreement or document which gives any Chargor a right to occupy or use property, (except any Security Assets specified in paragraph (a) above) wheresoever situate now belonging to it together with all buildings and Fixtures thereon, the proceeds of sale of all or any part thereof and the benefit of any covenants for title given or entered into by any predecessor in title and any moneys paid or payable in respect of such covenants subject, in the case of any leasehold properties, to any necessary third party's consent to such mortgage being obtained;

 - (ii) all plant, machinery, computers and vehicles now or in the future owned by it and, subject to any necessary third party's consent to such charge being obtained, its interest in any plant, machinery, computers or vehicles in its possession other than any for the time being part of the Company's stock in trade or work in progress;
 - (iii) all moneys (including interest) from time to time standing to the credit of each of its present and future accounts (including, without limitation, the Security Accounts, but excluding any Cash Collateral Prepayment Account) with any bank, financial institution or other person and the debts represented thereby, provided that without prejudice to any other provision of Clause 4 of the Debenture, any such monies paid out of such accounts without breaching

the terms of the Secured Finance Documents and not paid into another such account in the name of the Company shall be released from the fixed charge effected by this sub-paragraph (iii) upon the proceeds being so paid out;

- (iv) (to the extent not effectively assigned under Clause 4.3 of the Debenture) all proceeds in respect of the Insurances and all claims and returns of premiums in respect thereof;

- (vii) any beneficial interest, claim or entitlement of it to any assets of any pension fund;
- (viii) its present and future goodwill;
- (ix) the benefit of all present and future licences, permissions, consents and authorisations (statutory or otherwise) held in connection with its business or the use of any of the Security Assets specified in paragraphs (a) and (b) above and sub-paragraph (i) above and the right to recover and receive all compensation which may at any time become payable to it in respect thereof;

- (xii) all stocks, shares, debentures, bonds, warrants, coupons or other securities and investments now or in the future owned by any or (when used in relation to a particular Chargor) that Chargor from time to time not charged pursuant to Clause 4.2 of the Debenture, excluding shares in Joint Ventures over which Encumbrances are not permitted (or not permitted without consent of another party) by the terms of the agreements stabilising and regulating such Joint Ventures (as in effect at the date hereof),

PROVIDED THAT any property or assets situate in Scotland and any property or assets the rights in and to which are governed by the laws of Scotland shall be excluded from the mortgages and charges created or effected by paragraphs (a) to (c) inclusive above.

2. Pursuant to the terms of the Debenture, the Company as sole beneficial owner and with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994, hereby as continuing security for the payment, discharge and performance of all the Secured Liabilities at any time owed or due to the Secured Parties (or any of them):

- (a) mortgages and charges and agrees to mortgage and charge to the Security Agent (as agent and trustee for the Secured Parties) all Group Shares held now or in the future by it and/or any nominee on its behalf, the same to be a security by way of a first mortgage; and
- (b) mortgages and charges and agrees to mortgage and charge to the Security Agent (as agent and trustee for the Secured Parties) all the Related Rights accruing to all or any of the Group Shares held now or in the future by it and/or any nominee on its behalf, the same to be a security by way of a first mortgage or charge.

PROVIDED THAT:

- (i) whilst no Event of Default has occurred or is continuing, all dividends and other distributions paid or payable as referred to in paragraph (b) above may be paid directly to the relevant Chargor (in which case the Security Agent or its nominee shall promptly execute any necessary dividend mandate) and, if paid directly to the Security Agent, shall be paid promptly by it to the relevant Chargor;
- (ii) whilst no Event of Default has occurred or is continuing, the Security Agent shall use all its reasonable endeavours to forward to the relevant Chargor all material notices, correspondence and/or other communication it receives in relation to the Group Shares; and
- (iii) subject to Clause 10.2 of the Debenture, whilst no Event of Default has occurred or is continuing, all voting rights attaching to the relevant Group Shares may be exercised by the relevant Chargor or, where the shares have been registered in the name of the Security Agent or its nominee, as the relevant Chargor may direct in writing, and the Security Agent and any nominee of the Security Agent in whose name such Group Shares are registered shall execute any form of proxy or other document reasonably required in order for the relevant Chargor to do so.

- For the purposes of Clause 4.2 of the Debenture only the definition of Group Shares shall exclude any shares held in the share capital of Tetley Australia Pty Limited from time to time.
- 3(a) Pursuant to the terms of the Debenture, the Company as beneficial owner and with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994, as continuing security for the payment, discharge and performance of the Secured Liabilities at any time owed or due to the Secured Parties (or any of them), hereby assigns and agrees to assign to the Security Agent (as agent and trustee for the Secured Parties) all its right, title and interest (if any) in and to:
- (i) any and all proceeds of the Insurances;
 - (ii) the Hedging Agreements;
 - (iii) the Intra Group Loan Agreements;
 - (iv) the Tata Joint Venture Agreement;
 - (v) the Empirical Joint Venture Agreement;
 - (vi) the Southern Tea Joint Venture Agreement; and
 - (vii) the Tetley ACI Joint Venture Agreement.
- (b) To the extent that any such right, title and interest described in paragraph (a) of Clause 4.3 of the Debenture is not assignable or capable of assignment, the assignment thereof purported to be effected by paragraph (a) shall operate as an assignment of any and all damages, compensation, remuneration, profit, rent or income which the Company may derive therefrom or be awarded or entitled to in respect thereof, in each case as continuing security for the payment, discharge and performance of the Secured Liabilities at any time owed or due to the Secured Parties (or any of them).
- (c) Whilst no Event of Default exists (or an Event of Default has occurred but has been waived) (i) the Security Agent shall permit the relevant Chargor to exercise its rights (other than to receive payment of money) under any Relevant Agreement to which it is party, **PROVIDED THAT** the exercise of these rights in the manner proposed would not result in a Default under the terms of the Senior Finance Documents or the SRCF Finance Documents, and (ii) any payments received by the Security Agent under or in respect of the Relevant Agreements by virtue of this Debenture shall be paid by the Security Agent to the relevant Chargor save to the extent required by the terms of the Senior Facility Agreement, the SRCF Agreement or, as the case may be, the Priority Agreement to be applied against any of the Secured Liabilities which are then due and payable (or as a result of such receipt become due and payable).
4. Pursuant to the terms of the Debenture, the Company as beneficial owner and with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994, as security for the payment, discharge and performance of the Secured Liabilities, charges in favour of the Security Agent (as agent and trustee for the Secured Parties) by way of a first floating charge all its undertaking and assets whatsoever and wheresoever both present and future (including, without limitation, any undertaking and assets situated in Scotland (whether or not the same may be mortgaged or charged by way of standard security)), subject always to

all mortgages, fixed charges and assignments created by or pursuant to Clause 4 of the Debenture or any other provision of the Debenture.

5. Pursuant to the terms of the Debenture:

(a) Except as provided below, the Security Agent may by notice only to any Chargor convert the floating charge hereby created into a specific charge as regards all or any of such Chargor's assets, rights and property (except to the extent that any such conversion is ineffective under the laws of Scotland in respect of any such assets, rights and property situated in Scotland) specified in the notice:

- (i) if an Event of Default has occurred and is continuing and has not been waived by the Security Agent; or
- (ii) if the Security Agent in good faith considers such assets, rights or property to be in danger of being seized or sold under any form of distress, attachment, execution or other legal process or to be otherwise in immediate jeopardy; or
- (iii) if such Chargor fails to comply, or takes or threatens to take any action which in the reasonable opinion of the Security Agent is likely to result in it failing to comply with its obligations under Clause 5.2 of the Debenture.

(b) The floating charge hereby created may not be converted into a fixed charge solely by reason of:

- (i) the obtaining of a moratorium; or
- (ii) anything done with a view to obtaining a moratorium,

under the Insolvency Act 2000.

(c) The floating charge hereby created shall (in addition to the circumstances in which the same will occur under general law) automatically be converted into a fixed charge over the assets, rights and property of any Chargor:

- (i) if an administrator is appointed or the Security Agent receives notice of an intention to appoint an administrator; or
- (ii) on the convening of any meeting of the members of such Chargor to consider a resolution to wind such Chargor up (or not to wind such Chargor up),

PROVIDED THAT Clause 5.3(c) of the Debenture shall not apply to any of the Chargor's undertaking and assets situate in Scotland if, and to the extent that, a Receiver would not be capable of exercising his powers in Scotland pursuant to Section 72 of the Insolvency Act 1986 by reason of such automatic conversion.

(d) The floating charge hereby created is a **qualifying floating charge** for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act 1986.

(e) The giving by the Security Agent of a notice pursuant to paragraph (a) above in relation to any class of any Chargor's assets, rights and property shall not be construed as a waiver or

abandonment of the Security Agent's rights to give other similar notices in respect of any other class of assets or of any other of the rights of the Secured Parties (or any of them) hereunder or under any of the other Secured Finance Documents.

6. The Company undertakes to each Lender that, save as expressly permitted under the terms of the Debenture, the Senior Facility Agreement and the SRCF Agreement it will not:
- (a) create or permit to subsist any Encumbrance over all or any of its assets, rights or property other than pursuant to this Debenture or any other Security Document; or
 - (b) part with, lease, sell, transfer, assign or otherwise dispose of or agree to part with, lease, sell, transfer, assign or otherwise dispose of all or any part of its assets, rights or property or any interest therein.

The following terms used in this Companies Form 395 have the meanings set out below:

Accession Agreement means an agreement substantially in the form of Schedule F made pursuant to Clause 19.1 (a **Borrower Accession Agreement**) or Clause 19.2 (a **Guarantor Accession Agreement**) or Clause 19.4 of the Senior Facility Agreement.

Additional Guarantor means any entity which becomes party hereto as a Guarantor pursuant to a Guarantor Accession Agreement.

Agent means:

- (a) when designated **Facility**, Rabobank International, London Branch or any of its successors appointed as such pursuant to the Senior Facility Agreement; and
- (b) when designated **Security**, Rabobank International London Branch or any of its successors appointed as such pursuant to the Senior Facility Agreement and/or any corresponding provision of any Security Document; and
- (c) without any such designation, the Facility Agent or the Security Agent, as the context requires.

Ancillary Bank means any Bank which becomes an Ancillary Bank pursuant to the Senior Facility Agreement.

Arranger has the meaning given to it in the SRCF Agreement.

Bank means each of Rabobank International, London Branch and The Royal Bank of Scotland plc or any other bank or financial institution or other person to which rights and/or obligations are assigned or transferred in accordance with the Senior Facility Agreement or which assumes rights and obligations pursuant to a Substitution Certificate (as defined in the Senior Facility Agreement).

Cash Collateral Prepayment Account has the meaning given to that term in the Senior Facility Agreement.

Chargors means Tata Tea (GB) Limited, the companies identified as Chargors in Schedule 1 of the Debenture together with each company which becomes a party to the Debenture by executing a Deed of Accession (each a **Chargor** and together the **Chargors**).

Collateral Account means each account maintained from time to time by the Company at such branch of the Account Bank as the Security Agent may from time to time approve being, at the Effective Date, those Accounts with the Account Bank identified in a letter dated the Effective Date from the Company to the Security Agent and countersigned by the Security Agent for the purposes of identification.

Convertible Loan Stock Creditor has the meaning given to it in the Priority Agreement.

Deed of Accession means a deed substantially in the form of Schedule 7 of the Debenture executed, or to be executed, by a Chargor.

Effective Date means the date (if any) on which the Facility Agent gives the notice referred to in Clause 4.1 of the Senior Facility Agreement.

Empirical Joint Venture Agreement has the meaning given to that term in the Senior Facility Agreement until the Senior Discharge Date and thereafter the meaning given to that term in the SRCF Agreement.

Encumbrance means any standard security, assignation in security, bond and floating charge, mortgage, pledge, lien, charge, assignment for the purpose of providing security, hypothecation, right in security, security interest or trust arrangement for the purpose of providing security, and any other security agreement or other arrangement having the effect of providing security (including, without limitation, the deposit of monies or property with a person with the primary intention of affording such person a right of set-off or lien).

Event of Default has the meaning given to that term (i) (prior to the Senior Discharge Date) in the Senior Facility Agreement and (ii) (after the Senior Discharge Date but prior to the SRCF Discharge Date) in the SRCF Agreement.

Existing Hedging Agreement means the confirmation dated 6th February, 2003 relating to Interest Rate Swap Reference 501175Q/00U04547 of the trade dated 30th March, 2000 and the confirmation dated 6th February, 2003 of Interest Rate Swap Reference 6376400/03U01394 of the trade dated 28th January, 2003 forming part of the ISDA Master Agreement between Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (trading as Rabobank International) and Tata Tea (GB) Limited dated 29th March, 2000.

Fixtures means, in relation to any freehold or leasehold property charged by or pursuant to this security, all fixtures and fittings (including trade fixtures and fittings) and fixed plant and machinery from time to time thereon owned by any Chargor.

Group means Tata Tea (GB) Limited and its Subsidiaries from time to time.

Group Shares means all shares specified in Schedule C to this Companies Form M395 or in the Schedule to any Deed of Accession or, when used in relation to a particular Chargor, such of those shares as are specified against its name in Schedule C to this Companies Form M395 or as are specified in the Schedule to a Deed of Accession to which it is party, together in each case with all other stocks, shares, debentures, bonds, warrants, coupons or other

securities and investments now or in the future owned by any or (when used in relation to a particular Chargor) that Chargor from time to time other than shares in Joint Ventures over which Encumbrances are not permitted (or not permitted without consent of another party) by the terms of the agreements establishing and regulating such Joint Ventures (as in effect at the date hereof).

Guarantor means each entity identified as a Guarantor in Schedule 1 Part 2 of the Senior Facility Agreement and each Additional Guarantor.

Hedging Agreements means the Existing Hedging Agreement and any and all other interest rate swap and/or interest rate cap and/or other hedging agreements entered into or committed to be entered into by any member of the Group as constitute Hedging Documents (as defined in the Priority Agreement) or have been (and/or may be) agreed in writing between the Company and the Facility Agent to constitute the Hedging Agreements.

Hedging Documents has the meaning given to that term in the Priority Agreement.

Hedging Banks means each bank and financial institution named in Schedule 4 of the Priority Agreement (if any) and any other bank or financial institution which becomes party to the Priority Agreement as a Hedging Bank pursuant to the Priority Agreement in each case in its capacity as provider of interest rate or currency exchange rate or other hedging facilities permitted by the terms of the Senior Finance Documents and the SRCF Finance Documents to one or more of the Obligors, and includes any person to whom any Hedging Liabilities may be payable or owing (whether or not matured) from time to time.

Hedging Liabilities means all present and future liabilities (actual or contingent) payable or owing by the Obligors or any of them to the Hedging Banks or any of them under or in connection with the Hedging Documents, whether or not matured and whether or not liquidated, together in each case with:

- (a) any novation, deferral or extension of any of those liabilities permitted by the Priority Agreement and the Hedging Documents;
- (b) any claim for damages or restitution arising out of, by reference to or in connection with any of the Hedging Documents;
- (c) any claim flowing from any recovery by an Obligor or a receiver or liquidator thereof or any other person of a payment or discharge in respect of any of those liabilities on grounds of preference or otherwise; and
- (d) any amounts (such as post-insolvency interest) which would be included in any of the above but for any discharge, non-provability, unenforceability or non-allowability of the same in any insolvency or other proceedings,

PROVIDED THAT, for the purposes of the Priority Agreement only and without prejudice to the liabilities secured by the Security Documents, the term Hedging Liabilities excludes (as against the SRCF Creditor but not as against any Convertible Loan Stock Creditor, Intercompany Creditor or any Investor):

- (i) any amount outstanding in excess of the limits specified in the Priority Agreement; and

- (ii) any amount outstanding and owed to a Hedging Bank which would not have been outstanding but for a breach of the Priority Agreement by that Hedging Bank.

Insurances means all contracts and policies of insurance (including, for the avoidance of doubt all cover notes) of whatever nature which are from time to time taken out by or on behalf of any Chargor or (to the extent of such interest) in which any Chargor has an interest.

Intellectual Property Rights means all know-how, patents, trade marks, service marks, designs, business names, domain names, topographical or similar rights, copyrights and other intellectual property rights and any interests (including by way of licence) in any of the foregoing (in each case whether registered or not and including all applications for the same).

Intercompany Creditor has the meaning given to it in the Priority Agreement.

Intra Group Loan Agreements means:

- (a) the intercompany loan agreement dated on or about the date hereof between Tata Tea (GB) Limited as borrower and certain other members of the Group as lenders; and
- (b) the intercompany loan agreement dated on or about the date hereof between certain members of the Group as borrowers and Tata Tea (GB) Limited as lender.

Investors has the meaning given to it in the Priority Agreement.

Issuing Bank means Rabobank International, London Branch.
