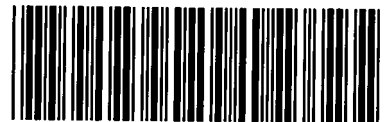



1. Statutory information

The Briars Residents Association Limited is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company information page.

2. Accounting policies

2.1 Basis of preparing the financial statements

The financial statements are prepared under the historical cost convention and in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006.

2.2 Significant judgements and estimates

The directors have not made any significant estimates or judgements in preparing these accounts.

2.3 Turnover

Turnover represents the total invoice value of contributions receivable in the year towards the maintenance of the common areas appertaining to certain properties at The Briars, Broomfield, Herne Bay, Kent.

The company, being a residents' association is not liable to corporation tax on its results.

4. Fixed assets

The company owns the communal land appertaining to certain properties at The Briars Broomfield Herne Bay Kent. This land was transferred to the company in a previous year for no cost.
