- the insertion in article 4A of the words "Except in respect of any issued shares in the Company held in the name, or subject to any security interest granted in favour, of a bank or financial institution" at the beginning of the current article 4A and that the first word "The" of the current article 4A is amended to "the", and
- 2 the deletion of the existing articles 3D and 3E
- 3 the insertion of a new article 3D immediately following article 3C which reads as follows -
- "3D Notwithstanding anything contained in these Articles to the contrary, the Directors will register any transfer of shares and may not suspend the registration of the transfer of any shares if such transfer
  - (i) is to the bank or institution to which such shares have been charged by way of security, whether as security trustee and/or agent for a group of banks or institutions or otherwise, or to any nominee or any transferee of such bank or institution (a "Secured Institution"),



- (11)is delivered to the Company for registration by a Secured Institution or its nominee in order to perfect its security over such shares, or
- (111) is executed by a Secured Institution or its nominee pursuant to a power of sale or other power under such security"
