

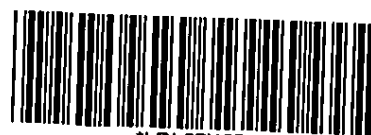

Company law requires the directors to prepare financial statements for each financial year that give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period.



2 PROFIT AND LOSS ACCOUNT


The company did not trade during the year and made neither a profit or loss. Accordingly, no separate profit and loss account has been presented in the financial statement.
