1. Accounting Policies

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective March 2000).

Turnover.

Turnover represents rent and services receivable.

Depreciation

Depreciation has not been provided on the leasehold property as it is held as an investment and has an unexpired term of over 20 years.

Depreciation is provided at a rate of 8% on cost on the plant and machinery.

Taxation

The charge to taxation is based on the result for the year and takes into account as appropriate, taxation deferred because of timing differences between the treatment of certain items for accounting and taxation purposes. Provision for deferred taxation is made under the liability method only to the extent that it is probable that the liability will become payable in the foreseeable future.

5. Other loan

The loan is interest free, unsecured, and is subordinated to the bank loan.

6. Share Capital

The authorised share capital of the company consists of 1,000 ordinary shares of £1 each. The issued, allotted and fully paid share capital consists of 2 ordinary shares of £1 each. There were no changes during the year.

7. Bank Loan

The bank loan is secured on the leasehold property and by a floating charge over the company's assets, and is repayable at the earlier of June 2003 or the sale of the property. The director has provided a guarantee to the bank for any shortfall of rental income over interest payable on the loan.

9. Related Party Transactions

This company is under the control of J.D.Robertshaw.

J.D.Robertshaw is the sole shareholder of New Brunswick Property Company Limited, which had advanced this company £145,621 at 31 December 2000 (31 December 1999 - £145,621). The loan is interest free and repayable on demand, and it is subordinated to the bank loan.

J.D.Robertshaw has provided a guarantee to the bank in respect of any shortfall of rental income over interest payable. At 31 December 2000, the company owed J.D.Robertshaw £17,990 (1999 - £17,559). This loan is unsecured, interest free and repayable on demand. It is subordinated to the bank loan.
