



Strategic report for the year ended 30 April 2023

The Directors present their strategic report and the audited financial statements for the year ended 30 April 2023.

Review of operations

The Company holds an investment in a company in Russia which operates two hotels, the five star Astoria Hotel and the four star Angleterre Hotel. Both hotels are located in St Petersburg and are under the management of Rocco Forte Hotels. Both hotels have been affected by the evolving political situation in Ukraine, which has impacted operations. The Directors continue to closely monitor developments.

The Company made a profit after taxation of £498,000 (2022 – £1,114,000). The Directors do not propose to pay a dividend this year (2022 - £Nil).

In addition to regular review of the financial performance of the company, the Directors closely monitor a number of financial and non-financial performance indicators in the underlying hotel investments. Hotel RevPAR results are compared to peer group competitive sets. Quality and service standards are measured based on third party audits and the wider Group undertakes independent employee engagement surveys to measure employee satisfaction and motivation.

The Directors were satisfied with the performance of the Company and its underlying hotel investments during the financial year, in light of the trading environment.

Principal risks and uncertainties

The Directors consider the following to be the principal risks and uncertainties facing the Company:

- global issues such as conflicts and disputes that could affect international travel;
- possible economic downturn and the associated impact on domestic and international travel;
- any terrorist activities that could deter international travel;
- any material global travel restrictions imposed on the hospitality industry;
- cyber-attacks that could disrupt business continuity or compromise the integrity and security of customer and employee data;
- the ability to retain and recruit sufficient numbers of skilled team members in an increasingly competitive employment market that could affect operational continuity and profitability;
- the availability of energy and food supplies and the related costs;
- increased competition and supply in the luxury hotel market in Russia; and
- exchange and interest rate movements (see financial risk management).

The Directors take measures to mitigate the Group and the Company's exposure to these risks on an ongoing basis. These risks and uncertainties are constantly monitored and managed through the Group's internal control processes and reporting structures.

The Russian subsidiary is ring-fenced from other financing structures in the Group. In response to the evolving political situation in Russia, the Group has introduced additional policies and procedures to manage the associated risks and to ensure appropriate authority to operate. The Directors continue to monitor the introduction of international sanctions and respond accordingly

Environmental sustainability

The Company is committed to minimising the impact of its underlying hotel investments on the environment and to adopting sustainable policies across all activities. Throughout the financial year, management has continued to enhance the wider Group's sustainability policies, which have been developed across four sustainability pillars of: community; people; planet; and business. The underlying hotel investments aim to operate with the highest ethical standards, develop managers and leaders to be strong supporters of caring for team members, strive to work with local suppliers to minimise CO2 footprint and support local charities and community organisations. Key activities undertaken at the hotels in the financial year include: promoting ESG Champions and the Sustainability Council; highlighting awareness amongst employees and guests; reducing the consumption of single-use plastic; implementing energy-saving solutions; and introducing waste-free options.


Duty to promote the success of the Company

The Board operates a standing rolling agenda of items aligned to the wider Group's operating and reporting cycles with approval, endorsement, review and monitoring functions. The Company places a high priority on positive and effective stakeholder engagement. 
The directors continue to monitor the risks associated with the introduction of international sanctions and the restricted trading environment impacting the Russian subsidiary and respond accordingly.

Opinion on the financial statements

In our opinion the financial statements:

- give a true and fair view of the state of the Company's affairs as at 30 April 2023 and of its profit for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

We have audited the financial statements of Rocco Forte & Family (Russia) Limited ("the Company") for the year ended 30 April 2023 which comprise Profit and loss statement, Balance sheet, Statement of changes in equity, and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 101 *Reduced Disclosure Framework* (United Kingdom Generally Accepted Accounting Practice).

Basis for opinion

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Extent to which the audit was capable of detecting irregularities, including fraud

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

- Making enquires of other personnel with roles relevant to compliance with laws and regulations.
- Communicating the relevant identified laws and regulations and potential fraud risks to all engagement team members and component audit teams, and remaining alert to any indications of fraud or non-compliance with laws and regulations throughout the audit.
- Assessing the susceptibility of the financial statements to material misstatement, including how fraud might occur in the financial statements and any potential indicators of fraud. We identified potential for fraud in the following areas and performed the following procedures:
 - Management override: We evaluated management's incentives and opportunities for fraudulent manipulation of the financial statements (including the risk of override of controls), and determined that the principal risks were related to posting inappropriate journal entries to manipulate financial results and management bias in accounting estimates and judgements. Audit procedures performed included:
 - challenging assumptions made by management in their significant accounting estimates for indications of bias or management override; and
 - identifying and testing manual journal entries, in particular any journal entries containing characteristics of audit interest such as manual journals to revenue, accounts receivable and cash; and for journals which are inconsistent with the usual transactions of the Group and Company.

As a result of these procedures, we considered the opportunities and incentives that may exist within the organisation for fraud and identified the greatest potential for fraud in management's incentive to manipulate earnings before tax.

Our audit procedures were designed to respond to risks of material misstatement in the financial statements, recognising that the risk of not detecting a material misstatement due to fraud is higher than the risk of not detecting one resulting from error, as fraud may involve deliberate concealment by, for example, forgery, misrepresentations or through collusion. There are inherent limitations in the audit procedures performed and the further removed non-compliance with laws and regulations is from the events and transactions reflected in the financial statements, the less likely we are to become aware of it.



1 Accounting policies

Statement of preparation

The financial statements have been prepared in accordance with the Companies Act 2006 and Financial Reporting Standard 101 *Reduced Disclosure Framework* ("FRS 101"). The principal accounting policies adopted in the preparation of the financial statements are set out below. The policies have been consistently applied to all the years presented, unless otherwise stated.

The financial statements have been prepared on a historical cost basis. The presentation currency used is pound sterling and amounts have been presented in round thousands ("£000s").

The Company's immediate and ultimate parent company, Rocco Forte Hotels Limited, includes the Company in its consolidated financial statements. The consolidated financial statements of Rocco Forte Hotels Limited, which is incorporated in the UK, are prepared in accordance with IFRS UK and are publicly available.

In preparing the financial statements the company has taken advantage of all disclosure exemptions conferred by FRS 101. Therefore the following disclosures have not been provided:

- a statement of cash flows;
- certain comparative information as otherwise required by IFRS UK;
- disclosure of related party transactions with other wholly owned members of the group headed by Rocco Forte Hotels Limited;
- certain financial instrument disclosures as provided in the consolidated financial statements of Rocco Forte Hotels Limited; and
- the effect of future accounting standards not yet adopted.

Exemption from preparation of group accounts

The financial statements contain information about Rocco Forte & Family (Russia) Limited as an individual company and do not contain consolidated financial information as the parent of a group. The company has taken advantage of the exemption conferred by section 401 of the Companies Act 2006 not to produce consolidated financial statements as it is included in the consolidated accounts of a larger group.

Going concern assessment

As described in Note 9 the Company is party to a Group loan facility over which Group lenders have a cross guarantee. The wider Group's position has been considered as part of the Going Concern assessment. The Company has prepared the financial statements for the year ended 30 April 2023 on a going concern basis.

Over the last year, trading restrictions imposed on the hospitality industry have been gradually relaxed and the Group has returned to full operational capacity and is cash generative. The Group agreed with lenders to implement a mechanism to revert to standard covenant obligation reporting in 2023, minimising future liquidity risk. Before confirming the appropriateness of the going concern basis of preparation, the directors considered the potential risks and uncertainties which may affect the Group.

The Directors believe that the Group and the Company have the resources required to settle all liabilities as they fall due for the foreseeable future. Accordingly, the financial statements have been prepared on a going concern basis.

The Russian subsidiary is ring-fenced from other financing structures in the Group. In response to the evolving political situation in Russia, the Group has introduced additional policies and procedures to manage the associated risks and to ensure appropriate authority to operate. The Directors continue to monitor the introduction of international sanctions and respond accordingly.

1 Accounting policies (continued)

Investments

Investments in subsidiaries are carried at cost less impairment. The carrying amount is reviewed at each reporting date to determine whether there is any indication of impairment. If such impairment exists, then the asset's recoverable amount is estimated. An impairment loss is recognised if the carrying amount of an asset exceeds its estimated recoverable amount. Impairment losses are recognised in the Profit and Loss Statement.

Amounts due from and amounts due to Group subsidiaries

Amounts due from and amounts due to Group subsidiaries are initially recognised at fair value. Subsequent to initial recognition they are measured at amortised cost using the effective interest method, less any impairment losses. The carrying value is reviewed at each reporting date to determine whether there is any indication of impairment. Impairment losses are recognised in the profit and loss statement.

Dividend distribution

Dividend distribution to the Company's shareholders is recognised in the financial statements in the period in which the dividends are approved and paid.

Foreign currency

Transactions in foreign currencies are translated to the Company's functional currency at the exchange rates ruling on the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are retranslated to functional currency at the relevant rates of exchange ruling on the last day of the period. Foreign exchange differences arising on translation are recognised in the profit and loss statement. Non monetary assets and liabilities that are measured in terms of historical cost in foreign currency are translated using the exchange rate at the date of transaction.

Income and expenses

Interest receivable and payable is recognised in the profit and loss statement as it accrues, using the effective interest rate method.

Dividend income is recognised in the profit and loss statement on the date the entity's right to receive payment is established.

Taxation

Current tax

Current income tax assets and liabilities for the current and prior periods are measured at the amount expected to be recovered from or paid to the tax authorities including interest. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted at the end of the reporting period.

Deferred tax

Deferred tax assets and liabilities are recognised in respect of temporary differences between the tax base and carrying value of assets and liabilities. Deferred tax assets are recognised to the extent that it is regarded as probable that the deductible temporary differences can be realised. The recoverability of all deferred tax assets is re-assessed at the end of each reporting period. Deferred tax is calculated at the tax rates that are expected to apply in the periods in which the asset or liability will be settled, based on rates enacted or substantively enacted at the end of the reporting period.

Critical accounting estimates and assumptions

The company makes certain estimates and assumptions regarding the future. Estimates and judgements are continually evaluated based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. In the future, actual experience may differ from these estimates and assumptions. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

Impairment testing

Investments and amounts due from group companies are tested for impairment when events or circumstances indicate that their carrying value may not be recoverable.

The recoverable amount is determined based on value in use calculations. The use of this method requires the estimation of future cash flows and the choice of a discount rate in order to calculate the present value of the cash flows. Information on the discount rates and key judgements are included in note 3 to the consolidated financial statements of Rocco Forte Hotels Limited. No impairment was identified for the year ended 30 April 2023.

The company continues to monitor the risks associated with the introduction of international sanctions and there is a level of judgement involved as a result of this uncertainty.
