1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The company ceased to trade in 2012 and as such these financial statements have been prepared on a break up basis.

These accounts present information about Hambrook estates Ltd as an individual undertaking and not about the group to which it belongs. Consolidated accounts are not prepared by the ultimate parent company Thornton Properties Limited on the basis that it qualifies as a small group for the period under review.

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

Taxation

Current tax is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
