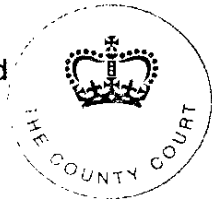
- (3) the Claimant do serve a copy of the Order on the Company's former Liquidator within 21 days of the date hereof

- (6) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"


- (7) the hearing fixed for the <sup>18<sup>th</sup> June 2020</sup> ~~10<sup>th</sup> October 2019~~ be vacated
