

BASIS OF ACCOUNTING

Inner Circle Business School London Limited is limited by guarantee and accordingly does not have share capital. The guarantor undertakes to contribute to the assets of the company, in the event of the company being wound up, a sum not exceeding one pound for payment of the debts and liabilities of the college.

3 PARENT COMPANY AND ULTIMATE CONTROLLING PARTY

The company's parent company and ultimate controlling party is The Inner Circle Educational Trust, a registered charity and a company limited by guarantee. The largest and smallest group of undertakings for which consolidated financial statements, including the company, have been drawn up was that headed by The Inner Circle Educational Trust. Copies of these financial statements can be obtained from the company's registered office at Inner Circle, Regent's Park, London, NW1 4NS.

4 RELATED PARTY TRANSACTIONS

Advantage has been taken of the exemption afforded by Financial Reporting Standard 8 'Related Party Disclosures' applicable to subsidiary undertakings regarding the non-disclosure of related party transactions with other group companies, where consolidated accounts are available.

5 POST BALANCE SHEET EVENTS

On 26 February 2021, the parent company The Inner Circle Educational Trust agreed to write off the amount of £990,642 owed by Inner Circle Business School London Limited. In doing so this releases any obligation in relation to the debt.
