**UPON THE PETITION** of Gregory Allison Clarke of Pinehurst, Friary Road, Ascot, Berkshire, SL5 9HD; John Michael Elsom of 30 Knighton Grange Road, Leicester, LE2 2LE; Mark Thomas Fonnoughty of 66 Hopefield Road, Leicester, LE3 2DL; Martin Francis George of Fotheringhey Manor, Fotheringhey, Peterborough, Cambridgeshire, PE8 5HZ; Stephen Andrew Kind of Staunton House, Littleworth Lane, Belton in Rutland, Uppingham, LE15 9JZ; William Kenneth Shooter of 5 Vincent Close, Leicester, LE3 6ED; and Brigid Mary Simmonds of 17a Chartfield Avenue, Putney, London, SW15 6DX ("**Petitioners**"), being all of the directors of the Leicester City Football Club PLC ("**City PLC**"), presented to the Court on Monday 21 day of October 2002

**AND UPON HEARING** Counsel for the Petitioners

**AND UPON READING** the evidence

**AND** the Court being satisfied on the evidence before it that the EC Regulation on Insolvency Proceedings (Council Regulation (EC) No 1346/2000) ("**EC Regulation**") does apply and that these proceedings are main proceedings as defined in Article 3 of the

## EC Regulation

IT IS ORDERED that during the period for which this order is in force the affairs, business and property of City PLC be managed by the joint administrators appointed by this order pursuant to the provisions of section 8 of the Insolvency Act 1986 for the following purposes:

1. The survival of City PLC, and the whole or some part of its undertaking as a going concern;
2. The approval of a voluntary arrangement with its creditors under part I of the Insolvency Act 1986;
3. A more advantageous realisation of City PLC's assets than would be effected on a winding-up.

AND IT IS ORDERED that:-

1. Nicholas James Dargan, Andrew Philip Peters, and Dominic Lee Zoong Wong of Deloitte & Touche of 180 Strand, London, WC2R 1BL be appointed joint administrators of the City PLC ("**Administrators**");
2. pursuant to the provisions of Rule 7.51 of the Insolvency Rules 1986 ("**Rules**") and CPR 3.1(2)(a) the time for service of the petition under Rule 2.7 of the Rules upon City PLC, Prudential Trustee Company Limited and the ~~Administrators~~ be abridged;
3. any act required or authorised under any enactment to be done by an administrator may be done by either or any or all of the Administrators;
4. pursuant to Rule 7.31(5) of the Rules, appendices 4 and 5 to the report prepared by Nicholas James Dargan pursuant to Rule 2.2 of the Rules ("**Report**") are not open to inspection without leave of the Court;
5. the costs of and occasioned by this petition and of the evidence filed in support of this petition including the Report and including all legal costs relating thereto be paid as an expense of the administration.
