

**ORDER**

---

UPON the Application of Ian Best, Mark Boughey and Ernst & Young LLP dated 17 June 2013.

AND UPON reading the witness statement of Ian Best dated 14 June 2013, exhibit "IB1" and the witness statement of Mark Boughey dated 14 June 2013

**IT IS ORDERED THAT:**

1 In respect of those administrations listed in Schedule A and the liquidations listed in Schedules B and C to this Order which are the subject of proceedings in the Birmingham District Registry or the Leeds District Registry that these proceedings be transferred to the Companies Court, Chancery Division, High Court of Justice, solely for the purpose of making the Order contained in paragraphs 2 to 13 below

2 In respect of those companies listed in Schedules A, B and C attached hereto, Ian Best be removed from office with effect from the date of the order of the Court

3. In respect of those companies in administration listed in Schedule A hereto, Mark Boughey be appointed as joint administrator in place of Ian Best with effect from the date of the order of the Court



4. In respect of those companies in creditors' voluntary liquidation listed in Schedule B hereto, Mark Boughey be appointed as joint liquidator in place of Ian Best with effect from the date of the order of the Court

In respect of those companies in members' voluntary liquidation listed in Schedule C hereto, Mark Boughey be appointed as joint liquidator in place of Ian Best with effect from the date of the order of the Court.

6 In respect of any companies in administration in Schedule A hereto that have transitioned to a creditors' voluntary liquidation pursuant to paragraph 83 of schedule B1 to the Insolvency Act 1986 as at the date of this Order (but which were in administration as at the date of issue of the application notice), Mark Boughey be appointed as joint liquidator together with Tomislav Lukic or Maurice Moses in such liquidations, in place of Ian Best

7. Ian Best shall be released from all liability in respect of his acts and omissions and otherwise in respect of his conduct as administrator and liquidator (as the case may be) of the companies detailed in Schedules A, B and C, such release to

take effect in relation to each relevant estate 28 days after the filing of the next report

8. The Applicants shall be entitled to.

8.1 Publish in the London Gazette composite notices relating to all of the resignations and appointments as detailed in Schedules A, B and C and must do so within 14 days of the date of this Order, and

8.2 Apportion the costs of the said composite London Gazette notice between the said estates equally

9. Without incurring any additional expense to any of the said estates, the Applicants shall

9.1 Notify the Secretary of State as soon as reasonably practicable of the making of this Order; and

9.2 When the next report is due to creditors of each estate, notify the creditors of the making of this Order, and provide an explanation of the effect of the Order

10. In respect of the estates in Schedules A, B and C, the costs of this Application (including disbursements and VAT) summarily assessed at £5000 plus counsel's fees at £460.00 each figure to include VAT in addition be aggregated and apportioned equally between each of those estates, provided that if the costs which fall to be borne by any one of the estates exceeds 10% of the realisable assets within that estate, that estate shall only bear such part of those apportioned costs as equals 10% of that estate's assets, and the excess shall be borne by Ernst & Young LLP.

11 Pursuant to Rules 2.47(4) and 2.47(5) of the Insolvency Rules 1986, the period for filing the next report or routine report in respect of each administration, be extended to two months after the date of the Order

12 Pursuant to Rule 4.49C(7) of the Insolvency Rules 1986, the period for filing the next report or routine report in respect of each creditors' voluntary liquidation, be extended to two months after the date of the Order



- 13      Permission to each creditor and member of each estate to apply to vary or discharge this Order by an application issued within 28 days of receipt of the notice directed to be sent under paragraph 9 2 above
