No director who held office on 31 December 2005 had an interest in the company's shares either during the financial year or at 31 December 2005.


**Statement of directors' responsibilities**


For the year ended 31 December 2005 the company was entitled to exemption under section 249AA(1) of the Companies Act 1985.

### 5. Ultimate parent undertaking and Controlling party

The ultimate parent undertaking is Suez SA, a company incorporated in France.

The smallest such group is that headed by SITA Holdings UK Limited, a company registered in England & Wales. In the opinion of the directors, SITA Holdings UK Limited controls the company as a result of controlling 100% of the issued share capital of SHUKCO 305 Limited. Suez SA is the ultimate controlling party, being the ultimate controlling party of SITA Holdings UK Limited.
