### **Final Progress Report to the Sole Member**

This is the Liquidators' final progress report to the sole member covering the period 26 September 2014 to 2 September 2015

### **Statutory information**

I was appointed Joint Liquidator of the Company together with Roderick Weston by Written Resolution of the member on 26 September 2014. My address is Mazars LLP, Tower Bridge House, St Katharine's Way, London, E1W 1DD.

We are authorised to act as Insolvency Practitioners in the UK by the Institute of Chartered Accountants in England and Wales.

The current registered office of the company is Tower Bridge House, St Katharine's Way, London, E1W 1DD and its registered number is 03320907.

The former registered office was situated at Roman House, 13-27 Grant Road, Croydon, CR9 6BU.

### **Details of progress**

#### **Receipts and payments Account**

I attach a copy of my receipts and payments account for the period 26 September 2014, date of my appointment, to 2 September 2015.

#### **Assets**

The directors' declaration of solvency disclosed assets comprising an inter company book debt of £10,000 owed from Mansell plc.

The surplus assets in the liquidation total £10,000.

#### **Liabilities**

There were no preferential or unsecured creditor liabilities.

Following their appointment, the Liquidators gave notice by advertisement for creditors to submit details of their claims as required by statute. No such claims were received.

#### **Distributions to Shareholder**

The surplus assets of £10,000 were distributed in specie on 27 July 2015 to the beneficiary shareholder, Mansell Plc. The distribution represented a return of £1 per ordinary share of £1 in respect of their shareholding of 10,000 ordinary shares.

#### **Tax Clearance**

Formal tax clearance has been received from HM Revenue & Customs in respect of the pre and post appointment periods.

### **Liquidators' Fees and Disbursements**

The Liquidators' remuneration was approved by the Shareholder on 26 September 2014 as a fixed fee of £1,500 plus disbursements and VAT in relation to the winding up the Company. The disbursements comprise of statutory advertising and statutory bonding costs.

An invoice in respect of the Liquidators' fees and disbursements will be raised and sent to Balfour Beatty plc for settlement.

### **Dissolution**

Following the final meeting, we will file a summary of the Liquidators' receipts and payments with the Registrar of Companies. The Company will be struck from the register three months thereafter.
