



1.1 Accounting convention

Deferred taxation is provided at appropriate rates on all timing differences using the liability method only to the extent that, in the opinion of the directors, there is a reasonable probability that a liability or asset will crystallise in the foreseeable future

Professional indemnity insurance for members is charged when payable as it relates to subscriptions from members
