NOTES TO THE FINANCIAL STATEMENTS for the year ended 30 September 2014

1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention in accordance with applicable Accounting Standards in the United Kingdom. A summary of the more important accounting policies, which have been applied consistently in both periods, is set out below.

Consolidated accounts

Countywide Waterside Development Limited is exempt under section 400 of the Companies Act 2006 from the requirement to prepare consolidated accounts as it and its subsidiary and joint venture undertakings are included in the consolidated accounts of its parent undertaking, Gallagher Investments Holdco Limited. The financial statements therefore contain information about Countywide Waterside Development Limited as an individual company.

Limited Partnerships

The company's share of the limited partnership's net profit is accounted for using the equity method. Its share of profit following acquisition is taken to the profit and loss account with a corresponding increase in the investment. This profit is not considered to be a distributable reserve until cash is received from the limited partnership. Tax arising on the share of the limited partnership's profits is borne directly by the members and is therefore accounted for in the company.

Going concern

Notwithstanding the fact that at 30 September 2014 the company had net current liabilities, net liabilities and made a loss for the year, the financial statements have been prepared on a going concern basis as the company has received confirmation of financial support from Countywide Developments Limited, its intermediate parent company.

Cash flow statement

The company is a wholly-owned subsidiary of Gallagher Investments Holdco Limited and is included in the consolidated accounts of Gallagher Investments Holdco Limited, which are publicly available. Consequently, the company has taken advantage of the exemption from preparing a cash flow statement under the terms of FRS1 (revised) - 'Cash flow statements'.

Taxation

Current tax, including UK corporation tax, is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantially enacted by the balance sheet date.

Full provision is made on a non-discounted basis for deferred tax assets and liabilities arising due to timing differences between the recognition of gains and losses in the financial statements and their recognition in the tax computation at the current rate of tax. Deferred tax assets are only recognised when it is considered more likely than not that they will be realised.
