INTRODUCTION

The Royal Aero Club Trust was founded as a Charity in 1998 The Trust has two principal objectives:-

- (i) The conservation of the collection of memorabilia of the Royal Aeio Club of the United Kingdom (RAeC) and the dissemination of its contents to a much wider public
- (11) Promoting the development of young people by helping them achieve their physical, social and spiritual potential through participation in air sports and aviation related activities. Full details of the Trust activities can be found on its website www.royalaeroclubtrust.org

PERIOD COVERED BY THIS REPORT

This report covers the period from 1st January 2011 to 31st December 2011

PUBLIC BENEFIT SUMMARY

The records and artefacts in the conservation programme are available to all members of the public seeking further information from the archives of the RAeC through an application to the Trust or to the Royal Air Force Museum Hendon. Copies of specific records are available for a small fee. Historical records and aviation records are available through the Trust's website and search engine.

The Flying for Youth programme grants a number of bursaries each year, which are available to applicants providing those applicants raise a sum equal to the bursary from their own resources or through their own efforts

THE ROYAL AERO CLUB COLLECTION

GENERAL

The collection includes more than 900 files (500 boxes) of archival material including albums, books, publications and reference works, Aviators' Certificates (dating back to pre WWI), more than 70 paintings and sculptures and numerous items of historic silverware. The collection is a significant part of the United Kingdom's 19th and 20th Century aviation heritage and continues to grow. During the course of the year new and valuable artefacts have been discovered

The most valuable items are kept at the RAF Museum Hendon but some are also held at other locations including the Museum of Science & Industry, Manchester. Some items are on public display and others are stored in secure conditions

The conservation of the Collection and its continuing maintenance is as in previous years a cause for concern to the Trustees and the RAeC who recognise its National importance and the responsibility we owe to future generations, not just to aviators but the public at large. As in previous years the Trust has achieved much in the conservation and preservation of the Collection. This would not have been possible without the support of our Benefactors and the unpaid Trustees and their unpaid volunteers.

The Trust has during the year been in negotiation with the RAeC with a view to the Club gifting its entire Collection to the Trust so as to ensure its safekeeping for future generations. It is anticipated that the transfer will be completed by early 2012

PAINTINGS and SCULPTURES

The catalogue of all RAeC paintings and sculptures prepared over several years continues to be updated by Trustee, Dick Poole, to whom the Trust is extremely grateful. This catalogue is published on the Trust website and is worthy of an inspection

CUPS, TROPHIES and SILVERWARE

As stated previously the Trust's catalogue of all RAeC cups, trophies and silverware has as previously reported, been completed and continues to be updated and maintained. The catalogue enables the Trust to identify those items which are in need of conservation and

repair. Due to limited funds the Trustees follow a careful selection process so as to prioritise the items in most need of conservation and/or restoration.

Although referred to in previous reports it is worth mentioning again that the Club owns and has on display at the RAF Museum, Hendon the '1st Aero Club Cup'. This was the very first aviation trophy to be presented in the World. It was awarded to the winner of an Air Race in London in 1906. As before, this quite amazing trophy will also be on public display at major aviation events throughout the U K

ROYAL AERO CLUB AVIATORS' CERTIFICATES

As followers of aviation history will know, until 1950 the RAeC and not HM Government issued civilian pilots with their flying Certificates (Licences). The Trust maintains approximately 28,000 index cards and 34 photograph albums of aviators who were issued with their flying licences by the RAeC from 1910-1950. As well as civilian pilots the RAeC issued the very first licences to military and naval pilots.

The first Aviator's Certificate was awarded by the RAeC more than 102 years ago on 8th March 1910.

The Trust must once again thank Cross & Cockade International and its volunteers for their continued support with unlimited research on behalf of the Trust and the RAeC

THE RACC ARCHIVES and VOLUNTEERS

The Trust continues to receive outstanding support from its unpaid volunteers.

These volunteers ably led by Trustee Andrew Dawrant spend many thousands of hours preserving and conserving historical records. These records are absolutely vital for the Nation and for future generations. The volunteers have the thanks of the Trust for this vitally important work which would otherwise be beyond the financial means of the Trust. The Council of the RAeC repeatedly records its gratitude to the Trustees, the Trusts Management Committee and the Volunteers

Thanks must again go to the Royal Air Force Museum Hendon, its Director General, Air Vice-Marshal Peter Dye (Retired), and Staff for its and their invaluable contribution to storage, display and conservation of important historical records. Also for invaluable advice freely given

The magnitude of the tasks facing all volunteers cannot be overstated. It will still take several years to complete the current projects. These projects could not be carried out at all if they had to be undertaken on a commercial basis

There is attached to this Report an Appendix itemising the additional work carried out during the year

PRESS OFFICER

Kayt Peters joined the team as Press Officer and has operated to great effect with member organisations of the RAeC and with newspapers local to the Trust's bursary winners. She has produced some excellent publicity for the Trust and it is expected that this will result in even greater public interest in both the bursary programme and the RAeC archives in the years to come

BRITISH AVIATION PRESERVATION COUNCIL

The Trust is a member of the British Aviation Preservation Council, an organisation "linking national, local authority, independent and service museums with private collections, voluntary groups and other organisations in the advancement of aviation preservation"

CONSERVATION OF UNIQUE ITEMS

The Trust continues to thank the Museum of Science & Industry Manchester for storing free of charge security copies of Archival Microfilm in temperature controlled conditions. This results in the microfilm being preserved for the next 250 years

THE FLYING FOR YOUTH PROGRAMME

FLYING BURSARIES

During 2010 the Trustees awarded flying bursaries to young people to assist them to progress from a basic level in their chosen air sport to a higher level of skill and competence. In addition to the bursaries funded by the Trust itself, the Trust awards bursaries sponsored by The Royal Aeronautical Society. Also in particular the Trust thanks Peter Cruddas CRAeC, Dr. Brian Bramson and Mr. John Downer for their financial and other support which has led directly to the preservation of important parts of the Nations aviation heritage and has directly supported Flying Bursaries. Indeed the improved finances of the Trust, referred to earlier, enabled it to award no fewer than 24 bursaries in 2011. Although thanks to our Bursaries Manager, Mr. David Bills, have been given elsewhere in this report, I am pleased to announce that Mr. Bills has been appointed a Trustee.

FLIGHT SIMULATOR BURSARIES AWARDED TO PERSONAL COMPUTER PILOTS

A major objective of the Trust is to encourage young people to become involved in all forms of recreational and leisure activities in the air including air sport. Many young people still perceive air sport and its related leisure activities to be expensive and elitist and consequently an adventure activity beyond their wildest dreams. To dispel this perception the Trust offers bursaries to qualified PC pilots to provide real or hands-on experience of flying as well as activities such as parachuting and designing, building and flying model aeroplanes and rockets

Up to date information concerning the successful applicants who were awarded bursaries is displayed on the Trust's website

OTHER ACTIVITIES

DISPLAY STANDS

As stated previously we continue to thank Air Vice-Marshal Peter Dye (Retired) (and the Trustees of the Royal Air Force Museum for the enormous support they provide A major part of the Trust's collection of memorabilia, Trophies, etc. in addition to those of the RAeC, are on public display at the Museum and archived material can be accessed there

FUND RAISING

A major and necessary task of the Trust is to raise funds for its various conservation, preservation and bursary projects. Fund-raising activities take a tremendous amount of time and energy. This is particularly so in the economic recession which has now continued for several years. The Trustees would like to pay tribute to and thank HRH. The Duke of York for the time he gives as Patron of the Trust. This commitment by HRH has without doubt assisted in fund raising to a level against the national trend. This has placed the Trust in a more financially secure position than pre-recession
