

# LIQUIDATOR'S ACTIONS SINCE APPOINTMENT

Following my appointment I took steps to notify all of the relevant parties of my appointment, make requests for information regarding the Company's affairs, and to deal with such work required under the Insolvency legislation such as advertise my appointment.

The information passed to me from the Official Receiver advised of no known assets, however, my investigations remain ongoing.

There is certain work that I am required by the insolvency legislation to undertake in connection with the liquidation that provides no financial benefit for the creditors. A description of the routine work undertaken since my appointment as Liquidator is contained in Appendix 1.

#### **RECEIPTS AND PAYMENTS**

My Receipts & Payments Account for the period from 9 November 2018 to 8 November 2019 is attached at Appendix 2.

#### ISA Quarterly Fees

The sum of £88.00 has been paid with respect to ISA quarterly fees.

#### O.R. Debit Balance

The sum of £9,400.00 has been paid with respect to O.R debit balance.

#### **LIABILITIES**

#### Secured Creditors

An examination of the Company's mortgage register held by the Registrar of Companies, showed that the Company has no current charges over its assets.

The legislation requires that if the Company has created a floating charge after 15 September 2003, a prescribed part of the Company's net property (i.e. the money that would otherwise be available to the charge holder) should be ring-fenced for distribution to unsecured creditors. In this case there were no creditors secured by a floating charge such that the prescribed part provisions do not apply.

#### Preferential Creditors

The statement of affairs anticipated no preferential creditors. No claims have been received.

#### Crown Creditors

The statement of affairs included £Nil owed to HMRC. HMRC's claim of £806,110.42 has been received.

#### Non-preferential unsecured Creditors

The statement of affairs did not include any non-preferential unsecured creditors. I have not received any claims.

#### **DIVIDEND PROSPECTS**

Based upon the information currently available there will be no dividend to any class of creditor.

#### INVESTIGATION INTO THE AFFAIRS OF THE COMPANY

I undertook an initial investigation into the Company's affairs to establish whether there were any potential asset recoveries or conduct matters that justified further investigation, taking account of the public interest, potential recoveries, the funds likely to be available to fund an investigation, and the costs involved.

As stated previously, my investigations into the affairs of the Company remain ongoing.

#### LIQUIDATOR'S REMUNERATION

My total time costs to 8 November 2019 amount to £2,941.00, representing 12.9 of hours work at a blended charge out rate of £227.98 per hour. I have not been able to draw any remuneration in this matter as the basis of my remuneration has not yet been fixed by creditors.

An unsecured creditor may, with the permission of the Court, or with the concurrence of 5% in value of the unsecured creditors (including the creditor in question), request further details of the Liquidator's remuneration and expenses within 21 days of their receipt of this report. Any secured creditor may request the same details in the same time limit.

An unsecured creditor may, with the permission of the Court, or with the concurrence of 10% in value of the unsecured creditors (including the creditor in question), apply to Court to challenge the amount of remuneration charged by the Liquidator as being excessive, and/or the basis of the Liquidator's remuneration, and/or the amount of the expenses incurred as being excessive, within 8 weeks of their receipt of this report.
