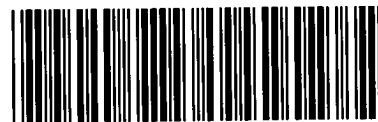



**1 Accounting policies****1.1 Basis of Preparation**
