#### **DIRECTOR'S REPORT**

The trustees are very grateful to the Mandalay trust for a grant of £3750 UBT had no paid staff during the year but recognised a need to prepare a strategy of activities in line with its commitment to tackling racism and Islamophobia.

We were fortunate to be able to engage Sonia Mehta, from the Change Institute, to help the trustees decide what was possible within the limited fundraising capacity of a small chanty at this time

In fact the options for a distinctive programme were limited. The trustees decided to revive the successful promotion of positive contacts between British Muslims and British Jews, which we had done in previous years under the banner of 'Alif-Aleph UK'.

Alia Hussain was taken on as a volunteer, and paid for all her expenses and the costs of two events. Receipts were submitted and filed and her work was supervised by Rokhsana Fiaz and Richard Stone.

One event was an Iftar in a synagogue. Iftar is the breaking of the Ramadan fast. 40 people attended. 14 were Muslims 5 were Jewish members of Alif-Aleph. The other 21 were members of the synagogue, for many of whom this was the first time they had met any Muslims.

The other event which Alia helped facilitate was a performance at the Tricycle Theatre in Kilburn, London, by MUJU. This is a Muslim-Jewish under 25s theatre group.
