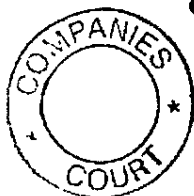

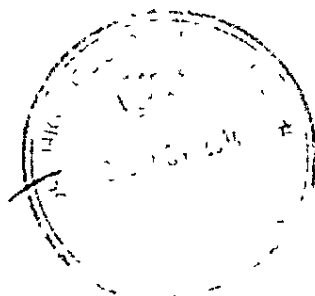

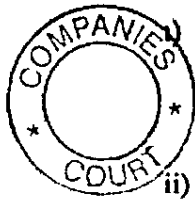

IT IS ORDERED as follows:-

1. That in respect of each bankruptcy listed in Schedule A attached hereto, pursuant to sections 298, 300 and 303(2) of the Insolvency Act 1986 and Chapter 1A, Part 7, Rule 7 10B(2)(c) of the Insolvency Rules 1986 Rebecca Jane Dacre be removed as Trustee and Peter John Windatt be appointed in her place Rebecca Jane Dacre be released from the date hereof pursuant to section 299(3)(c) of the Insolvency Act 1986.

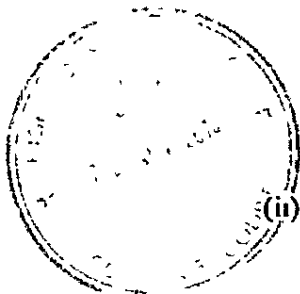

8. That in respect of those cases proceeding in the County Courts listed in Schedules A, B, C, D, E, F and G, pursuant to Section 41 (1) of the County Courts Act and Chapter 1A, Part 7, Rule 7.11 of the Insolvency Rules 1986 the proceedings be transferred to the High Court of Justice for the purpose only of this Application and forthwith after the making of this Order be retransferred to those County Courts.
9. Notwithstanding the removal of the Applicant and the appointment of one of the Respondents as Trustees in Bankruptcy of the individuals listed in Schedule A to this Order any progress reports that are filed in relation to this individual will continue to cover the period specified in Rule 6.78A(3) of the Insolvency Rules 1986.
10. Notwithstanding the removal of the Applicant and the appointment of the Respondents as the Liquidators of the companies listed in Schedules H and I to this Order any progress reports that are filed in relation to each of these companies will continue to cover the period specified in Rule 4.49C – CVL(2) of the Insolvency Rules 1986
11. Notwithstanding the removal of the Applicant and the appointment of one of the Respondents as the Liquidators of the companies listed in Schedules F and G to this Order any progress reports that are filed in relation to each of these companies will continue to cover the period specified in Rule 4.49B(4) of the Insolvency Rules 1986.
12. That the Applicant Rebecca Jane Dacre shall be at liberty to notify the creditors of each estate by advertisement, such advertisement to be made within 28 days of the date of the making of this Order and to be placed in the London Gazette provided that such advertisement should list every case and, where applicable, the Court reference and shall specifically draw the attention of the creditors to the permission to apply contained in paragraph 15 below.
13. That this Order and its effects shall be specifically drawn to the attention of creditors in the office holder's next report to creditors.



- 14 That pursuant to Chapter 1A, Part 7, Rule 7.10D(4) of the Insolvency Rules 1986 the costs of this application shall be borne in equal shares by each of the estates identified in Schedules A to K to this Order provided that the costs borne by any one of the estates shall not exceed 10 percent of its reasonable assets.
15. That there be permission given to each creditor of each estate to apply to vary or discharge this Order within 28 days of the notification referred to in paragraph 12 above.
