1. Principal accounting policies

The financial statements have been prepared in accordance with applicable Accounting Standards in the United Kingdom. A summary of the more important accounting policies, which have been applied consistently, is set out below.

(a) Basis of accounting

The accounts are prepared on the historic cost convention.

(b) Basis of preparation

As at 30 June 2001 all contracts had expired. There is no intention to continue or renew trading and consequently the company has ceased to trade on its own account. The parent company, Volkswagen Financial Services (UK) Limited, has indicated that it will provide financial support to enable the company to cover any outstanding obligations.

(c) Cashflow statement

The company is a wholly owned subsidiary of Volkswagen Financial Services (UK) Limited

The directors have adopted the provisions of FRS 1 (revised 1996) and have taken advantage of the exemption allowing them to dispense with the preparation of a cashflow statement on the grounds that the company is included in the consolidation financial statements of it's parent undertaking which are publicly available.

(d) Related parties

The company's voting rights are controlled within the group headed by Volkswagen AG. The directors have adopted the provisions of FRS 8 and have taken advantage of the exemption of the disclosure requirements regarding intra group related party transactions and balances.
